- Instructions:** 1. You may apply before **November 17, 2011** by completing this form and returning it to Regional District of Central Okanagan, 1450 KLO Road, Kelowna BC, V1W 3Z4 OR by email to maryjane.drouin@cord.bc.ca. The form must include your full name, full residential address, full address of real property if you are a non-resident property elector, and an address where you wish to have the mail ballot package mailed.
2. If you are a qualified elector and your application is completed correctly, the Chief Election Officer will send you a mail ballot package once we have received the ballots (early November), by regular letter-mail via Canada Post. If time does not permit mailing, you should arrange to pick up a package from the Chief Election Officer.
3. You are responsible for ensuring your completed ballot is received by the Regional District of Central Okanagan Chief Election Officer no later than 8:00 pm on general voting day, Saturday, November 19, 2011.

- a resident of BC for at least the past 6 months immediately before general voting day; **AND**
- not disqualified by law from voting in an election; **AND**
- entitled to vote in this election and have not previously voted in this election.

I further declare that I am entitled to vote by mail for the following reason(s) (**you must qualify for at least one**):

- I have a physical disability, illness or injury that affects my ability to vote at another voting opportunity for this election; **AND/OR**
- I expect to be absent from the Regional District of Central Okanagan at the times of all advance voting opportunities (November 9 & 15, 2011) and on general voting day (November 19, 2011).
