NOTICE OF NOMINATION

PUBLIC NOTICE is given to the electors of:

School District No. 23 (Central Okanagan) Zone I being:

District of Lake Country and Regional District of Central Okanagan - Central Okanagan East Electoral Area (Ellison, Joe Rich) of the Regional District of Central Okanagan.

And to the electors of **School District No. 23 (Central Okanagan) Zone II** being:

District of Peachland and Regional District of Central Okanagan - Central Okanagan West Electoral Area (Traders Cove, Fintry, Killiney Beach, Westshore Estates, Wilson's Landing, rural Peachland, and Tsinstikeptum Indian Reserves 9 and 10).

Nominations will be accepted for the following offices:

One (1) School Trustee for Zone I of School District No. 23 (Central Okanagan)

One (1) School Trustee for Zone II of School District No. 23 (Central Okanagan)

Candidates for Zone 1 shall be nominated in writing by two persons who are qualified electors of School District Zone 1 for which the person is nominated.

Candidates for Zone 11 shall be nominated in writing by two persons who are qualified electors of School District Zone 11 for which the person is nominated.

A person is qualified to be nominated and elected to hold office, if they meet the following criteria:

- Age 18 or older on general voting day for the election;
- A Canadian citizen;
- A resident of British Columbia for at least 6 months immediately before the day nomination papers are filed; and
- Not disqualified by the *Local Government Act*, *School Act*, or any other enactment from voting in an election in British Columbia or from being nominated for, being elected to, or holding office.

At the time of filing the nomination documents, the candidate shall also file with the Chief Election Officer or a person(s) designated by the Chief Election Officer, a written disclosure as required under the *Financial Disclosure Act*.

Nomination papers for qualified candidates will be available for pick up at the following locations, and will be received as follows:
