## Recommendation

THAT Regional District of Central Okanagan Sterile Insect Release Parcel Tax Amendment Bylaw be given first, second and third readings, and adopted this 8<sup>th</sup> day of April 2010.

## BACKGROUND

Amendments to the above bylaw are required as follows:

- 1) #5 As the parcel tax rate is established annually and is approved in the budgeting process. Delete 5 in its entirety and replace. Schedule A is therefore not required.
- 2) #6 – Add the title Director of Finance and Administrative Services.

Staff requests that the amended resolution be considered for adoption.

A bylaw to amend the Regional District of Central Okanagan Sterile Insect Release Parcel Tax Bylaw No. 1159, 2006

---

WHEREAS, the Regional District of Central Okanagan has enacted the Regional District of Central Okanagan Sterile Insect Release Parcel Tax Bylaw No. 1159

AND WHEREAS, the Regional District of Central Okanagan considers that it is necessary to amend the Regional District of Central Okanagan Sterile Insect Release Parcel Tax Bylaw No. 1159

NOW THEREFORE, the Regional District of Central Okanagan in open meeting assembled enacts as follows:

1. Delete 5 in its entirety

"5. The parcel tax rates shall in accordance with Schedule 'A' of this bylaw. This parcel tax will be used to cover a portion of the cost of operating the Okanagan-Kootenay Sterile Insect Release service as provided for in the Sterile Insect Release Board's final annual budget."

**And replace with the following:**

"5. The parcel tax rates used to cover a portion of the cost of operating the Okanagan-Kootenay Sterile Insect Release service shall be established annually by the Sterile Insect Release Board in their final annual budget, and also approved by the Regional Board through the budget process.

2. Delete 6 in its entirety

6. "The Corporate Officer of the Regional District, or such other person as may be appointed annually by resolution of the Regional Board, shall be appointed as the collector for the preparation and amendment of the Sterile Insect Release Parcel Tax Assessment Roll.

**And replace with the following:**

6. "The Corporate Officer or the Director of Finance and Administrative Services of the Regional District, or such other person as may be appointed annually by resolution of the Regional Board, shall be appointed as the collector for the preparation and amendment of the Sterile Insect Release Parcel Tax Assessment Roll."

3. Delete Schedule 'A' in its entirety

4. Citation
