**BYLAW NO. 1330**

Being a bylaw to amend the boundary of the North Westside Road Fire Protection Local Service Area

---

WHEREAS the Regional Board of the Regional District of Central Okanagan established by Bylaw No. 548 cited as the "Regional District of Central Okanagan North Westside Road Fire Protection Local Service Area Establishment and Expansion Bylaw No. 548, 1993" a service to provide fire protection to a portion of Electoral Area 'G', now known as Central Okanagan West Electoral Area.

AND WHEREAS the Regional Board deems it necessary to expand the said service area to include the area shown on Schedule "A" attached hereto;

AND WHEREAS the Regional Board has received a valid petition in accordance with Section 797.4 of the *Local Government Act* to amend the said service area boundary to include:

1. The boundary of the North Westside Road Fire Protection Local Service Area, established by the "Regional District of Central Okanagan North Westside Road Fire Protection Local Service Area Establishment and Expansion Bylaw No. 548, 1993", as amended, is hereby amended by deleting Schedules "A" and "B", and replacing it with Schedule "A" attached hereto and forming part of this bylaw.
2. This bylaw may be cited as the "Regional District of Central Okanagan North Westside Road Fire Protection Local Service Area Establishment and Expansion Amendment Bylaw No. 1330, 2013".

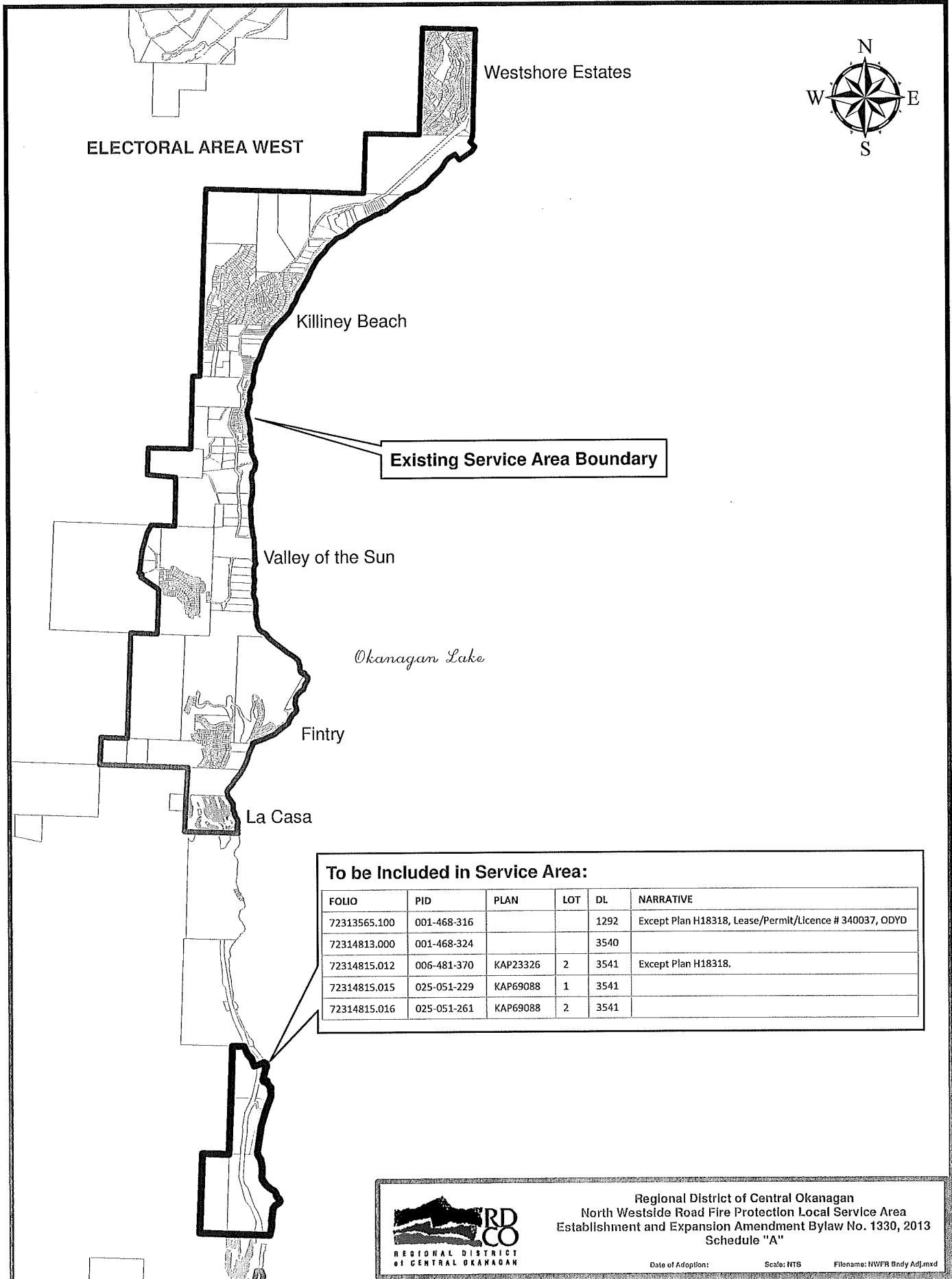

To the Board of Directors:

We, the undersigned owners of the land described below, hereby petition the Board of the Regional District of Central Okanagan to expand the North Westside Fire Rescue Fire Protection Area to include the subject properties as listed below. The current operation and maintenance costs for the fire protection area are \$0.8035 per \$1000.00 of assessment or \$80.35 per year for \$100,000.00 assessment, which will be collected through taxation.
