

REGIONAL DISTRICT OF CENTRAL OKANAGAN

BYLAW NO. 1334

Being a bylaw to amend the Regional District of Central Okanagan Noxious Insect and Pest Control Extended Service Establishment Bylaw No. 649

WHEREAS the Regional District of Central Okanagan has adopted the "Regional District of Central Okanagan Noxious Insect and Pest Control Extended Service Establishment Bylaw No. 649, 1996";

AND WHEREAS the District of West Kelowna has expressed a desire to assume responsibility for weed control within their boundaries and the Regional Board has agreed to this;

AND WHEREAS it is deemed necessary to amend the said service area to delete the District of West Kelowna (formerly known as a portion of Electoral Area H and Electoral Area G);

AND WHEREAS the Councils of the District of West Kelowna, Corporation of the District of Peachland, District of Lake Country and the Directors of Central Okanagan West Electoral Area and Central Okanagan East Electoral Area have consented in writing to the adoption of this Bylaw;

AND WHEREAS the City of Kelowna participates in the extended service through a contract with the Regional District of Central Okanagan;

AND WHEREAS consent of 2/3 of the participants has been given pursuant to section 802 (1)(b) of the *Local Government Act*;

NOW THEREFORE the Regional District of Central Okanagan, in open meeting assembled, enacts as follows:

1. That Section 2 be deleted and replaced with the following:

"The boundaries of the defined portion of Central Okanagan West Electoral Area are hereby extended to include the whole of the electoral area for the purpose of this service.

The participating areas in the service established are: Central Okanagan East Electoral Area, Central Okanagan West Electoral Area, Corporation of the District of Peachland, and the District of Lake Country."

2. That section 3 be deleted in its entirety and the remaining bylaw be numbered accordingly.

3. That Section 4 be deleted and replaced with the following:

"The annual cost for the service provided under Section 1 shall be recovered by the requisition of money to be collected by property value tax to be levied and collected upon land and improvements within the participating areas under Section 803(1)(a) of the *Local Government Act*.

- 4. The Noxious Insect and Pest Control service shall be reviewed on a five-year cycle, or earlier at the discretion of the Regional Board.
- 5. This Bylaw may be cited for all purposes as the "Regional District of Central Okanagan Noxious Insect and Pest Control Service Establishment Amendment Bylaw No. 1334, 2013".





At the June 11, 2013 District of West Kelowna Council meeting the following motion was adopted:

(A) NOXIOUS INSECT AND PEST CONTROL

THAT the District of West Kelowna provide formal confirmation to the Regional District of Central Okanagan (RDCO) of the District's desire to withdraw from the Regional District's Noxious Insect and Pest Control Service, effective December 31, 2013; and

THAT the District of West Kelowna notify RDCO of the District's decision to assume responsibility for noxious insect control within West Kelowna; and

THAT Council direct staff to develop a municipal noxious insect and pest control program, using existing staff resources, for implementation on January 1, 2014.

(B) NOXIOUS WEED CONTROL

THAT the District of West Kelowna provide formal confirmation to RDCO of the District's desire to withdraw from the Regional District's Noxious Weed Control Service, effective December 31, 2013; and

THAT the District of West Kelowna notify RDCO of the District's decision to assume responsibility for noxious weed control within West Kelowna, and to provide a level of service within the municipality that is comparable to the level of service received under the Regional District's service; and

THAT Council direct staff to develop a municipal noxious weed control program, using existing staff resources, for implementation on January 1, 2014.

The District of West Kelowna formally notifies Regional District of Central Okanagan that the District of West Kelowna will be withdrawing from Noxious Insect and Pest Control and Noxious Weed Control functions.
