

RE-ZONING BY-LAW NO. 16

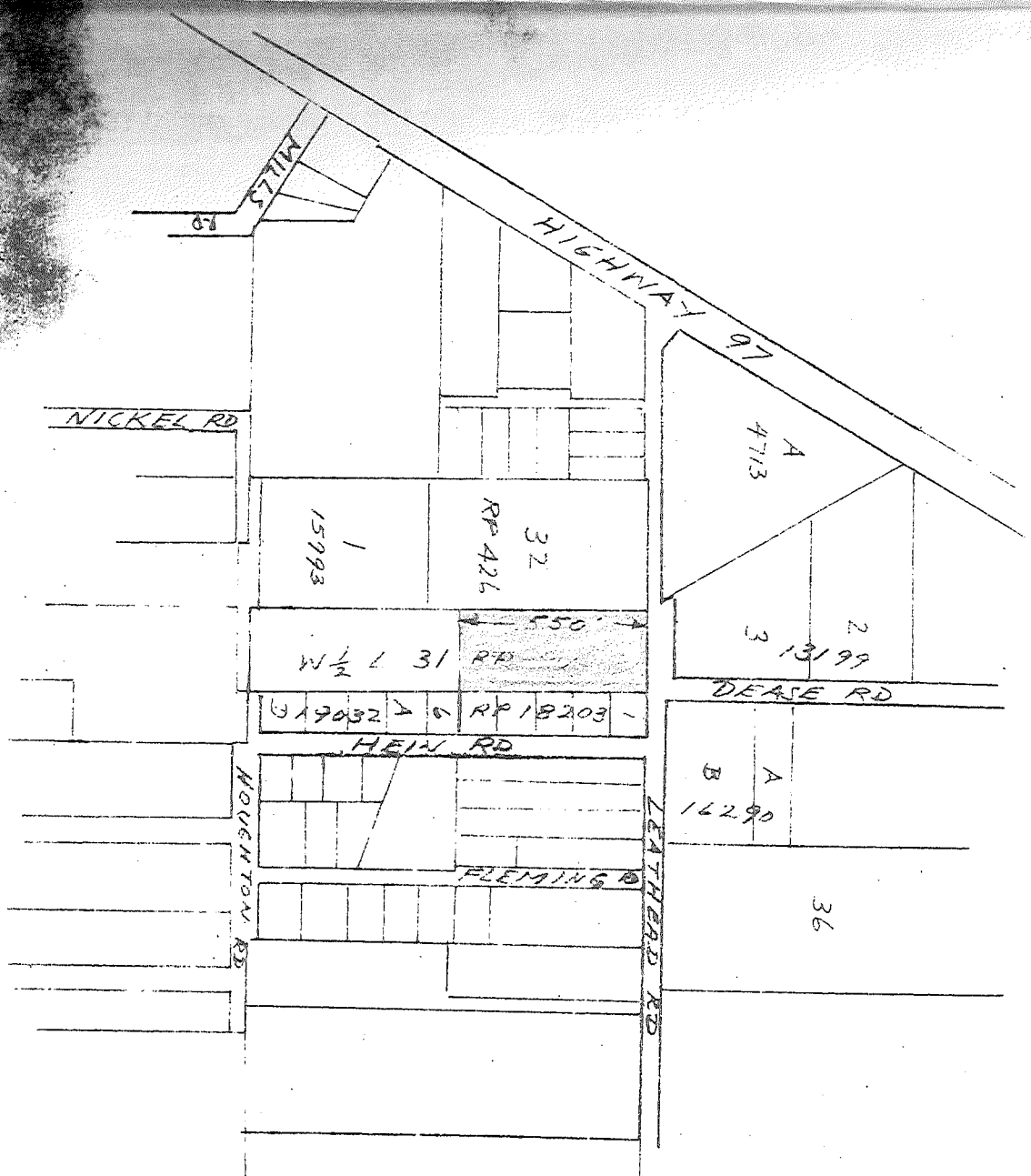
