

RE-ZONING BY-LAW NO. 22

A BY-LAW TO AMEND THE ZONING BY-LAW

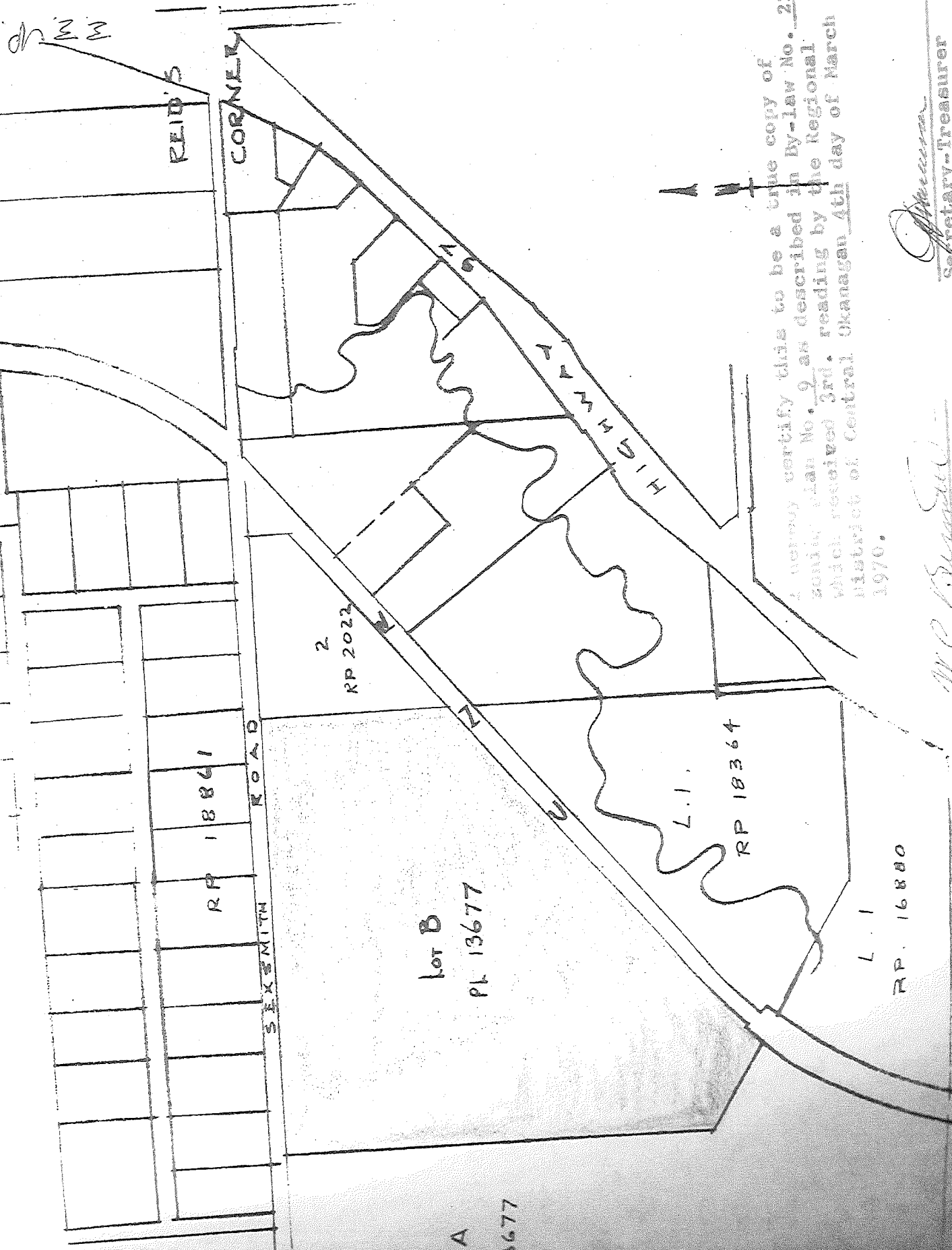
