

REGIONAL DISTRICT OF CENTRAL OKANAGAN

BY-LAW NO. 111

Being a By-law to amend the Specified Area By-law in Electoral Area 'G' for the purpose of providing street lights

WHEREAS the Regional Board of the Regional District of Central Okanagan adopted By-law No. 32 cited as the Casa Loma and Campbell Road Establishment By-law No. 32, 1971;

AND WHEREAS it is deemed advisable to amend the said by-law No. 32, so as to provide for the cost to be levied upon improvements only;

NOW THEREFORE the Regional District of Central Okanagan in open meeting assembled enacts as follows:

1. That By-law No. 32, cited as the "Casa Loma and Campbell Road Specified Area Establishment By-law No. 32, 1971" adopted the third day of March, 1971 is hereby amended by deleting Clause 2 therein and by substituting the following as Clause 2:

"the entire cost of providing streetlighting shall be borne by the owners of land in the said specified area and a sum sufficient therefore shall be levied and raised in the manner prescribed in the Municipal Act in each year commencing with the year 1976 for such period of time as is necessary on improvements only on the basis of assessment as fixed for taxes for school purposes, excluding property that is taxable for school purposes only by special act, within the said specified area".

2. This by-law may be cited as "Casa Loma and Campbell Road Specified Area Establishment Amendment By-law No. 111 , 1975.
