

REGIONAL DISTRICT OF CENTRAL OKANAGAN

BY-LAW NO. 153

---

Being a by-law to amend By-law No. 110 to include the provisions that no person shall keep, permit, suffer or allow any dog, which by its cries or barks, disturbs the quiet, peace, rest, enjoyment, comfort or convenience of any person within the Regional District of Central Okanagan

---

WHEREAS the Letters Patent of the Regional District of Central Okanagan issued by Order-in-Council the 9th day of June, 1977, by the Government of the Province of British Columbia, grants the powers and authorities contained in Clause (c) of Section 870 of the Municipal Act R.S.B.C. 1960;

AND WHEREAS the Letters Patent of the Regional District of Central Okanagan issued by Order-in-Council the 9th day of March, 1978, by the Government of the Province of British Columbia amended the Letters Patent issued the 9th day of June, 1977 regarding the function of Noise Control by adding Electoral Area 'I' as a participating member municipality.

NOW THEREFORE the Regional Board of the Regional District of Central Okanagan in open meeting assembled enacts as follows:

1. That the Regional District of Central Okanagan Dog Regulation and Impounding By-law No. 110, 1975 is hereby amended by re-numbering Sections 40 and 41 as Sections 41 and 42 respectively and inserting the following as Section 40:

Noise Nuisance 40 - No person shall keep, permit, suffer or allow any dog, which by its cries or barks, disturbs the quiet, peace, rest, enjoyment, comfort or convenience of any person within the Regional District of Central Okanagan.

2. This by-law may be cited for all purposes as the Regional District of Central Okanagan Dog Regulation and Impounding Amendment By-law No. 153 , 1978.
