

REGIONAL DISTRICT OF CENTRAL OKANAGAN

BY-LAW NO. 184

Being a by-law to provide for the borrowing of money in anticipation of receiving revenue through the issuance of debentures.

WHEREAS the Supplementary Letters Patent dated the 19th day of March, 1974, the Regional District of Central Okanagan was granted the function of providing Garbage Collection and Disposal within the areas of Electoral Area G and defined areas of Electoral Area H, being the participating member municipalities;

AND WHEREAS the maximum amount that the Regional District is authorized to borrow for the said Garbage Collection and Disposal is \$100,000.00;

AND WHEREAS the Westside Sanitary Land Fill Loan Authorization By-law #86, 1974 provided for the borrowing of \$50,000.00;

AND WHEREAS to provide the said Garbage Disposal it is now deemed necessary to provide additional equipment and facilities, the estimated cost of which includes incidental expenditures thereto is \$40,000.00;

AND WHEREAS the Regional Board of the Regional District of Central Okanagan intends to provide financing for the said facility by issuance of debentures through the Municipal Finance Authority of British Columbia;

NOW THEREFORE the Regional Board of the Regional District of Central Okanagan in open meeting assembled enacts as follows:-


- (1) The Board is hereby empowered and authorized to temporarily borrow upon the credit of the Regional District from the Canadian Imperial Bank of Commerce, Kelowna, British Columbia, an amount or amounts not exceeding \$40,000.00 plus interest charged thereon for the purpose of providing temporary financing for the acquisition of equipment and facilities for the Disposal of Garbage.


- (2) The Regional Board shall from time to time convert the funds borrowed, pursuant to this by-law, through the issuance of debentures by the Municipal Finance Authority of British Columbia.
- (3) The form of obligation to be given as acknowledgment of of the liability shall be a Promissory Note or Notes signed by the Chairman and the Treasurer of the Regional District of Central Okanagan.
- (4) This by-law may be cited as "The Regional District of Central Okanagan Westside Sanitary Landfill Temporary Borrowing By-law No. 184 , 1979."




