

REGIONAL DISTRICT OF CENTRAL OKANAGAN

BY-LAW NO. 224

Being a by-law to amend the Regional District of Central Okanagan Dog Regulation and Impounding By-law No. 110, 1975

WHEREAS it is deemed necessary to amend the Licensing & Impounding fees as established in the Central Okanagan Dog Regulation and Impounding By-law No. 110, 1975;

NOW THEREFORE the Regional Board of the Regional District of Central Okanagan in open meeting assembled, enacts as follows:

1. That Clause 6 (a) to (d) inclusive be amended by repealing and substituting it with the following wording:
 - (6) Every application for a license shall be accompanied by a license fee payable to the Secretary-Treasurer as follows:
 - (a) For each unspayed female or un-neutered male dog, a fee of \$25.00.
 - (b) For each spayed female or neutered male dog, a fee of \$10.00.
 - (c) For each kennel as defined in and by Section 5 hereof and subject to the restrictions of the Regional District Zoning By-law, a fee of \$25.00.
 - (d) For each farm dog used for the security and operation of a duly recognized farm or orchard, a fee of \$5.00 (owners of said dogs shall be exempt from the Kennel License requirement).

Before issuing a license for a spayed female dog, or neutered male dog, the Secretary-Treasurer may require the owner to furnish proof that the dog has been spayed or neutered.

Should such license fee not be paid by the 31st of January of the licensing year, the owner of any dog not so licensed shall pay a further fee of \$10.00 unless such license fee shall not have been payable by the 31st day of January of the licensing year.

License fees payable after July 31st of the licensing year will be 50% of those fees as stated in paragraphs (a) to (d) above.

2. That Clause 17, (a) to (d) inclusive be amended by repealing and substituting it with the following wording:
 - (17) The owner of any dog impounded pursuant to the provisions of this by-law may reclaim such dog on application to the poundkeeper at any time prior to its sale or destruction on proof of ownership and on payment of the following charges:
 - (a) If the license for the current year for the dog has been taken out by the owner, pursuant to this by-law, a sum not exceeding Twenty-Five (\$25.00) dollars for first impoundment.
 - (b)/

- (b) If no license for the current year for the dog has been taken out by the owner, pursuant to this by-law, the prescribed license fee and penalty if applicable, plus a sum not exceeding Twenty-Five (\$25.00) dollars for the first impoundment.
- (c) For the second impoundment of the same dog, a sum not exceeding Fifty (\$50.00) dollars.
- (d) For the third and each additional impoundment of the same dog, a sum not exceeding one hundred (\$100.00) dollars.
- (e) In addition to the charges as set forth in subsection (a) and (b) of this provision, a maintenance and sustenance fee of Three (\$3.00) dollars for each twenty-four hour period the dog has remained in the pound, will be charged.

3. This by-law may be cited for all purposes as "The Regional District of Central Okanagan Dog Regulation and Impounding Amendment By-law No. 224, 1981.
