

REGIONAL DISTRICT OF CENTRAL OKANAGAN

BY-LAW NO. 231

---

Being a by-law to amend the Regional Parks Regulation By-law No. 101, 1976.

---

WHEREAS the Regional Board adopted By-law No. 101, 1976 on the 19th day of July, 1976;

AND WHEREAS it is deemed necessary to amend said By-law No. 101;

NOW THEREFORE the Regional Board of the Regional District of Central Okanagan in open meeting assembled enacts as follows:

1. That the Regional District of Central Okanagan Regional Parks Regulation By-law No. 101, 1976 is hereby amended as follows:
  - (a) By repealing Clause 5, Hours of Use and replacing it with the following:
    5. Hours of Use - All Parks in the Regional District shall be closed to the use of the public and all vehicles from dusk until 6:00 a.m. of each and every day.
  - (b) By adding new clause (b) to Section 8 as follows:
    - (b) The Regional Board may exclude dogs or other animals or fowl from a park or portions thereof.
  - (c) By adding new clause (a) (VI) Section 14 as follows:
    - (a) (VI) - Any motorvehicle being used or driven in a destructive manner contrary to the provisions of this by-law.
  - (d) By repealing the first line in Clause 15 and by replacing it with the following:

That the Superintendent of Parks may cause signs to be erected in parks that;
  - (e) By repealing Clause 19 and replacing it with the following:
    19. Penalty - Every person who contravenes any of the provisions of this by-law is liable on summary conviction to a fine not exceeding One Thousand Dollars (\$1,000.00).


2. This by-law may be cited for all purposes as the "Regional District of Central Okanagan Regional Parks Regulation Amendment By-law No. 231 , 1982"

READ A THIRD TIME THIS 1st DAY OF February ,1982.






