BY-LAW NO.284

---

Being a by-law to amend the Regional District of Central Okanagan Dog Regulation and Impounding By-law No. 239, 1982

---

WHERE it is deemed necessary to amend the Central Okanagan Dog Regulation and Impounding By-law No. 239, 1982.

NOW THEREFORE the Regional Board of the Regional District of Central Okanagan in open meeting assembled, enacts as follows:

1. That the Central Okanagan Dog Regulation and Impounding By-law #239, 1982 be hereby amended.
  - (a) That Paragraph 2 of Section 7 of Part II, Licensing of dogs, be repealed and replaced with the following:

"Should such license not be paid by the 28th or 29th of February (as applicable) of the licensing year, the owner of any dog not so licensed, shall pay a further fee of two dollars (\$2.00). Before issuing a license for a spayed female or neutered male dog, the Secretary shall require the owner to furnish proof that the dog has been spayed or neutered."
  - (b) That Subsection (iii) to Section 32(b) of Part IV, Impounding of dogs be repealed and replaced with the following:
    - (iii) For the third offence by the person in question, the sum of \$150.00.
  - (c) That the following subsection be added as Subsection (iv) to Section 32(b) of Part IV, Impounding of dogs:
    - (iv) For the fourth or subsequent offence by the person in question, the sum of \$250.00.
  - (d) This by-law may be cited for all purposes as "The Regional District of Central Okanagan Dog Regulation and Impounding Amendment By-law No. 284, 1985"
