BYLAW NO. 328

---

Being a bylaw to establish, maintain and operate an Economic Development Commission

---

WHEREAS by Letters Patent, the Regional District of Central Okanagan is authorized to establish, maintain and operate an Economic Development Commission;

AND WHEREAS the Regional Board of the Regional District of Central Okanagan deems it advisable to establish, maintain and operate an Economic Development Commission;


NOW THEREFORE the Regional Board of the Regional District of Central Okanagan enacts as follows:


1. That an Economic Development Commission be established with the City of Kelowna, The District of Peachland and Electoral Areas A, G, H and I as participating member municipalities and to do all things necessary in connection therewith.
2. The annual net costs for the operation and maintenance of the Economic Development Commission shall be apportioned on the basis as set out in the Letters Patent.
3. The Economic Development Commission shall consist of representatives from twenty-five (25) various economic sectors within the Regional District, which may change from time to time, depending upon community prominence.
4. That the Economic Development Commission Board of Directors shall be comprised of the representatives from the following agencies:
  - 2 - Regional District of Central Okanagan
  - 1 - Corporation of the District of Peachland
  - 1 - City of Kelowna
  - 1 - School District #23 (Central Okanagan)
  - 1 - Kelowna Chamber of Commerce

Together with three (3) Directors elected from the Commission
5. That an Executive Committee comprising a Chairman and two (2) Vice Chairmen be elected annually by and from the Members of the Board of Directors, and who shall be the working body of the Commission.
6. The Board of Directors may from time to time appoint or establish standing or special committees to consider specific matters of concern or interest. Said committees shall consist of no less than three (3) members, including one member of the Board of Directors and two members of the other members of the Commission. The Commission "Board of Director" member shall be Chairman who shall report the activities of the Committee as required.

- 7. The organizational structure of the Commission shall be as outlined in Exhibit "A" attached to this bylaw.
- 8. The Regional Board may from time to time, as deemed necessary appoint an Economic Development Officer and support staff to carry out instructions and policies of the Commission Executive.
- 9. A budget shall be prepared annually by the Commission Executive and submitted to the Regional Board for consideration and approval.
- 10. This bylaw repeals and replaces Bylaw No. 154 cited as the "Regional District of Central Okanagan Economic Development Commission Bylaw No. 154, 1978" and Bylaw No. 237 cited as the "Regional District of Central Okanagan Economic Development Commission Amendment Bylaw No. 237, 1982".
- 11. This bylaw may be cited as the "Regional District of Central Okanagan Economic Development Commission Bylaw No. 328 , 1987"




