

REGIONAL DISTRICT OF CENTRAL OKANAGAN

BY-LAW NO. 333

---

A bylaw to establish a Specified Area within Electoral Area 'H' of the Regional District of Central Okanagan for the purpose of providing streetlighting.

---

WHEREAS the Regional Board of the Regional District of Central Okanagan has been requested by sufficient petition to establish a specified area for the purpose of providing streetlighting to the Menu Road area of Electoral Area H;

AND WHEREAS the Regional Board is empowered with respect to that part of the Regional District not within a city, district, town or village, to undertake any work or service under the provisions of Part XVI of the "Municipal Act":

NOW THEREFORE, the Regional Board of the Regional District of Central Okanagan in open meeting assembled, enacts as follows:

1. The Regional Board is hereby empowered and authorized:
  - (a) to establish in Electoral Area 'H' a Specified Area defined as follows and to be known as the "Menu Road" Specified Area and such area shall be comprised of those tracts of land described in Schedule 'A' attached hereto:
  - (b) to undertake and carry out or cause to be carried out and provide streetlighting in and for the said specified area and to do all things necessary in connection therewith.
2. The entire cost of providing streetlighting shall be borne by the owners of land in the said specified area and a sum, not to exceed \$0.35 per \$1,000.00 of assessment, shall be levied and raised in the manner prescribed in the "Municipal Act" in each year commencing with the year 1988 for such period of time as is necessary, on land and improvements on the basis of assessment as fixed for taxation for hospital purposes within the said Specified Area.

3. The Specified Area established by this by-law may be merged with any other Specified Area or areas for the same purpose whether contiguous or not, in the manner provided in Section 677 of the "Municipal Act".


4. This by-law may be cited as the "Menu Road Street Lighting Specified Area Establishment By-law No. 333 , 1987."





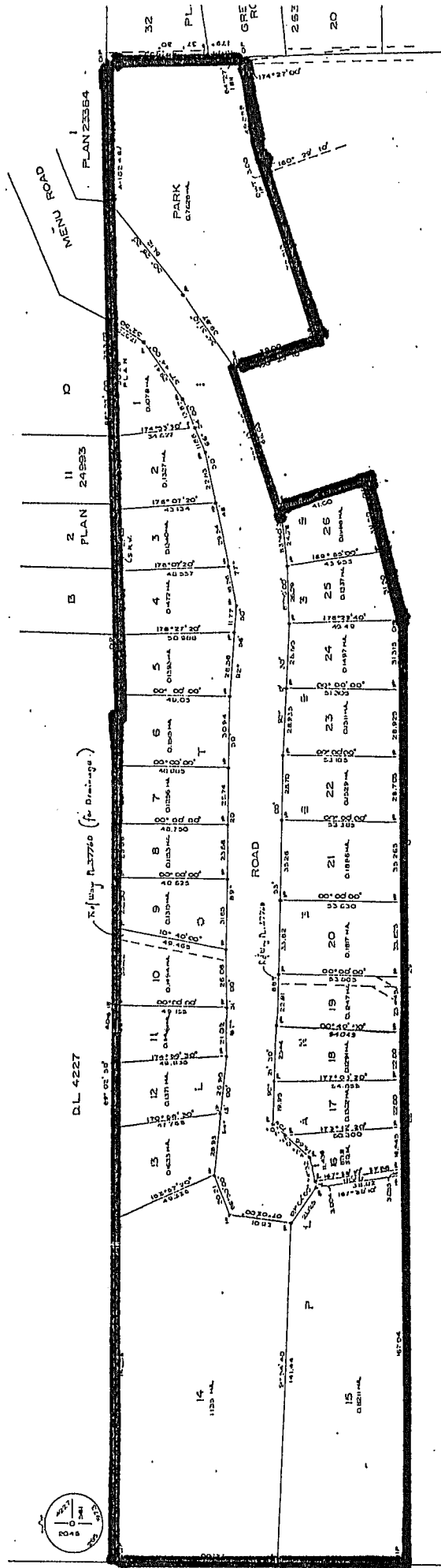
