BY-LAW NO. 346

Being a By-law to amend the Regional District of Central Okanagan Dog Regulation and Impounding By-law No. 292, 1985.

WHEREAS it is deemed necessary to amend the Central Okanagan Dog Regulation and Impounding By-law No. 292, 1985.

NOW THEREFORE the Regional Board of the Regional District of Central Okanagan in open meeting assembled, enacts as follows:

THAT Part II Licensing of Dogs be amended as follows:


1. To amend Section 7(b) by adding "That a kennel owner may obtain a kennel license in lieu of individual licenses for each dog kept therein."
2. To amend Section 8(a) to read "For each spayed or neutered farm dog used for security and operation of a duly recognized farm or orchard as defined by the Assessment Act of British Columbia (Statutory declaration by the owner is to accompany application) - \$5.00
3. To amend Section 8(c) to read "For each unspayed female or unneutered male dog" - \$35.00
4. To amend Section 8(d) to read "For each dog kept in a kennel and subject to the restriction of the Regional District Zoning Bylaw - \$25.00
5. To add the following as Section 8(e): "For a kennel, the owner of which chooses to license the kennel instead of each individual dog - \$125.00
6. To renumber Section 8, Subsections (e) (f) (g) (h) and (i) to Subsection (f) (g) (h) (i) and (j) respectively.
7. This by-law may be cited for all purposes as "The Regional District of Central Okanagan Dog Regulation and Impounding Amendment By-law No. 346, 1987".


