BY-LAW NO. 363

Being a By-law to amend the Regional District of Central Okanagan Building By-law No. 65, 1973.

WHEREAS it is deemed necessary to amend the Regional District of Central Okanagan Building By-law No. 65, 1973;

NOW THEREFORE the Board of the Regional District of Central Okanagan, in open meeting assembled, enacts as follows:

1. Regional District of Central Okanagan Building Bylaw No. 65, 1973 is hereby amended by repealing Clause 7(3)f and Schedule 'A' and replacing them with the following:

"7(3)f be accompanied with the permit fees as outlined on Schedule 'A' attached hereto and forming part of this by-law."

2. This By-law may be cited for all purposes as the Regional District of Central Okanagan Building Amendment By-law No. 363, 1988.




SCHEDULE "A" - SCHEDULE OF FEES

1. The fees charged for the issuance of permits under this bylaw shall be in conformance with the following schedule:
 - 1.1 For the erection, addition, alteration, repair, removal or demolition of a building or part thereof, building permit fees shall be 0.5 percent of the estimated construction cost.
 - 1.2 Building permit fees for plumbing shall be \$5.00 per fixture. For the purpose of establishing permit fees, each trap, roof drain, yard drain, and sump shall be classified as a fixture.
 - 1.3 Permits for the installation and set up of mobile homes in rural or residential zones shall be \$100.00 plus 0.5 percent of the cost of foundations, mountings, skirtings, blockings and service installations.
 - 1.4 Permits for the construction of a modular dwelling conforming to CSA A-277 shall be 0.5 percent of the total estimated construction cost.
 - 1.5 Permits for the set up of a mobile home in a mobile home park shall be \$30.00. Permit fee for additions thereto shall be based on Section 1.1 of this schedule.
 - 1.6 Permits for the construction of retaining walls shall be 0.5 percent of the construction cost.
 - 1.7 Permits for the construction of swimming pools shall be 0.5 percent of the construction cost.
2. Notwithstanding Sections 1.1 to 1.7 of this schedule, the minimum total fee for any permit shall be not less than \$30.00.
3. The permit fee for the inspection of an existing solid fuel burning appliance installation shall be not less than \$40.00.
