BY-LAW NO. 407

Being a bylaw to amend the Regional District of Central Okanagan Noxious Weed Control Bylaw #179, 1979

WHEREAS the Regional Board of the Regional District of Central Okanagan adopted the Regional District Noxious Weed Control Bylaw #179 on the 17th day of March, 1979 and;

WHEREAS it is deemed advisable and expedient to amend the said bylaw;

NOW THEREFORE THE REGIONAL BOARD OF THE REGIONAL DISTRICT OF CENTRAL OKANAGAN IN OPEN MEETING ASSEMBLED, ENACTS AS FOLLOWS:

1. That Bylaw #179, cited as the "Regional District of Central Okanagan Noxious Weed Control Bylaw #179, 1979" be amended by adding the following clause as 3(c) in Section II regulation as follows:

"3(c) Remove and clear from the property weeds and grasses that have been cut."

2. This bylaw shall be cited for all purposes as the "Regional District of Central Okanagan Noxious Weed Control Amendment Bylaw # 407, 1989".


