REGIONAL DISTRICT OF CENTRAL OKANAGAN

BYLAW NO. 410

---

Being a bylaw to convert a function to an extended service for the purpose of providing regional parks

---

WHEREAS the Regional Board of the Regional District of Central Okanagan may by bylaw establish and operate an extended service under the provisions of Part 24 of the Municipal Act;

AND WHEREAS the Lieutenant-Governor In Council of the Province of British Columbia by Supplementary Letters Patent dated the 25th day of October, 1974, and amended by Supplementary Letters Patent dated December 19, 1986, granted the power to the Regional District of Central Okanagan to acquire, develop, operate and maintain regional parks pursuant to the provisions of the Regional Parks Act, with the Electoral Areas of A, G, H and I, the City of Kelowna and the Corporation of the District of Peachland as participating areas in this service;

AND WHEREAS the Regional District of Central Okanagan wishes to convert the aforesaid function to an extended service;

NOW THEREFORE THE REGIONAL BOARD OF THE REGIONAL DISTRICT OF CENTRAL OKANAGAN IN OPEN MEETING ASSEMBLED ENACTS AS FOLLOWS:

1. The Regional Parks Function created by the issuance of Supplementary Letters Patent dated the 25th day of October, 1974 is hereby established as an extended service with the Electoral Areas A, G, H and I as electoral participating areas and the City of Kelowna and the Corporation of the District of Peachland as municipal participating areas
2. That the provisions of the Parks (Regional) Act R.S.B.C. 1979 apply to this extended service
3. The annual operating and debt servicing costs shall be recovered by a requisition of monies to be collected by a property value tax levied on the net taxable value of land and improvements, pursuant to the provisions of the parks (Regional) Act.
4. This bylaw may be cited as the "Regional District of Central Okanagan Regional Parks Extended Service Establishment Bylaw No. 410, 1990".


