

REGIONAL DISTRICT OF CENTRAL OKANAGAN

BY-LAW NO. 425

A by-law to convert a function to an extended service for the purpose of providing Dog Control.

WHEREAS the Regional Board of the Regional District of Central Okanagan may by by-law establish and operate an extended service under provisions of part 24 of the Municipal Act,

AND WHEREAS The Lieutenant Governor in Council of the Province of British Columbia by supplementary letters patent dated the 27th day of July, 1972 added Dog Control to the objects, powers, obligations, duties, limitations, and conditions of the Regional District of Central Okanagan and by subsequent amendments, with the Electoral Areas "A", "G", "H" and "I" as participating areas in this service,

AND WHEREAS the Regional District of Central Okanagan wishes to convert the aforesaid function to an extended service,

NOW THEREFORE the Regional Board of the Regional District of Central Okanagan in open meeting assembled enacts as follows:

1. The function of Dog Control created by the issuance of supplementary letters patent dated the 27th day of July, 1972, together with subsequent amendments, is hereby established as an extended service with the Electoral Areas "A", "G", "H" and "I" as electoral participating areas.
2. For the purposes of this extended service, the following sections of the Municipal Act RSBC 1979 apply:

524, 525, 932(s), 933, 1(d), 1(g), 2(a), 2(b), 2(c), 2(d), 4, 934, 934.1, 934.2, 934.3
3. The annual operating and debt servicing costs shall be recovered by a requisition of money to be collected by a property value tax off Land and Improvements pursuant to the provisions of the Municipal Act.
4. This by-law may be cited as the "Regional District of Central Okanagan Dog Control Extended Service Establishment By-law # 425, 1990".






