

REGIONAL DISTRICT OF CENTRAL OKANAGAN

BY-LAW NO. 429

Being a By-law to authorize temporary borrowing pending the sale of debentures.

WHEREAS it is provided by Section 342 of the Municipal Act that the Regional Board may, where it has adopted a loan authorization by-law, without further assents or approvals, borrow temporarily from any person under the conditions therein set out:

AND WHEREAS the Regional Board has adopted By-law No. 369, cited as "Falcon Ridge Water System Specified Area Establishment and Loan Authorization By-law No. 369, 1988" authorizing the construction of a domestic water system, the estimated cost of which, including incidental expenditures thereto, is Three Hundred and Forty Thousand, Four Hundred Twenty-two dollars (\$340,422.00), which is the amount of debt intended to be created by this by-law.

NOW THEREFORE the Regional Board of the Regional District of Central Okanagan in open meeting assembled, enacts as follows:

1. The Regional Board is hereby authorized and empowered to borrow from the Canadian Imperial Bank of Commerce, Main Branch, Kelowna, B.C. an amount or amounts not exceeding the sum of Three Hundred Forty Thousand, Four Hundred Twenty-two Dollars (\$340,422.00), as the same may be required, at an interest rate not exceeding that approved by the Inspector of Municipalities.
2. The form of obligation to be given as acknowledgment of the liability shall be a Promissory Note or Notes bearing the corporate seal and signed by the Chairperson and the Treasurer.
3. The money so borrowed shall be used solely for the purposes set out in said By-law No. 369.
4. The proceeds from the sale of debentures or so much thereof as may be necessary shall be used to repay the money so borrowed.


5. This by-law may be cited as the "Regional District of Central Okanagan Falcon Ridge Water System Temporary Borrowing By-law No. 429 , 1990."
