

REGIONAL DISTRICT OF CENTRAL OKANAGAN

BYLAW NO. 434

Being a bylaw to convert a specified area to a local service area.

WHEREAS under Section 767(4) of the Municipal Act, a Regional District exercising a power to provide a service other than a general service is required to adopt a bylaw respecting that service which:

- a) meets the requirements of Section 794 for an establishing bylaw, and
- b) is adopted in accordance with the requirement of Section 802 as if it were a bylaw amending an establishing bylaw

AND WHEREAS the Regional Board of the Regional District of Central Okanagan established by Bylaw No 229, 1982, cited as the Killiney Beach Water System Specified Area Establishment and Loan Authorization Bylaw No. 229, 1982, a specified area for the purpose of improving a domestic water system in the Killiney Beach Community within Electoral Area 'G'.

AND WHEREAS the Regional Board of the Regional District of Central Okanagan wishes to convert the aforesaid specified area to a local service;


NOW THEREFORE THE REGIONAL BOARD OF THE REGIONAL DISTRICT OF CENTRAL OKANAGAN in open meeting assembled enacts as follows:

1. The domestic water system specified area created under Bylaw 229, cited as the "Killiney Beach Water System Specified Area Establishment and Loan Authorization Bylaw No. 229, 1982," is hereby established as a local service for that portion of Electoral Area 'G' shown outlined on the plan attached, as Schedule 'A', to this bylaw and known as The Killiney Beach Water System Local Service Area.
2. The annual costs for the service shall be recovered by a requisition of money to be collected by a parcel tax, and by the imposition of fees and other charges that may be fixed by separate bylaw.
3. The maximum amount of monies that may be requisitioned for annual operating and debt servicing costs for the service provided under Section One shall not exceed \$8.57 per \$1000.00 of net taxable value of land and improvements within the service area.
4. This bylaw may be cited as the "Killiney Beach Water System Local Service Establishment Bylaw No. 434, 1990."


