BYLAW NO. 440

---

A bylaw to establish a local service within Electoral Area "A" to provide land for recreation purposes.

---

WHEREAS a regional district may, by bylaw, establish and operate a local service under the provisions of Part 24 of the Municipal Act;

AND WHEREAS the Regional Board of the Regional District of Central Okanagan wishes to establish a local service for the purpose of providing land for recreation purposes for Electoral Area "A";

AND WHEREAS, in accordance with Section 795(2)(a)(i) of the Municipal Act, the Regional Board has submitted the proposal to establish the local service to the electors within Electoral Area "A";

NOW THEREFORE THE REGIONAL BOARD OF THE REGIONAL DISTRICT OF CENTRAL OKANAGAN IN OPEN MEETING ASSEMBLED ENACTS AS FOLLOWS:

1. The Regional District hereby establishes Electoral Area "A", as described in Letters Patent of the Regional District of Central Okanagan, as a local service area for the purpose of providing land for recreation purposes.
2. The maximum amount of monies that may be requisitioned for annual operating and debt servicing costs for the service provided under Sections 1 of this Bylaw shall not exceed \$.19 per \$1,000.00 of net taxable value of improvements only within the service area.
3. The annual operating costs and debt servicing costs shall be recovered by requisition of monies to be collected by a property value tax levied on improvements only for regional hospital purposes, within the service area.
4. This bylaw may be cited as "Regional District of Central Okanagan Electoral Area "A" Recreation Land Local Service Area Establishment Bylaw No.440 , 1990".


