

REGIONAL DISTRICT OF CENTRAL OKANAGAN

BYLAW NO. 507

A bylaw to establish a local service within Electoral Area "A" to construct and operate a Shared Use Facility.

WHEREAS a Regional District may, by bylaw, establish and operate a local service under the provisions of Part 24 of the Municipal Act;

AND WHEREAS the Regional Board of the Regional District of Central Okanagan wishes to establish a local service for the purpose of constructing and operating a Shared Use Facility.

AND WHEREAS, in accordance with Section 795(2)(a)(i) of the Municipal Act, the Regional Board has submitted the proposal to establish the local service to the electors within Electoral Area "A";

NOW THEREFORE THE REGIONAL BOARD OF THE REGIONAL DISTRICT OF CENTRAL OKANAGAN in open meeting assembled enacts as follows:

1. **Service being established**

The service being established under this bylaw is the local service of constructing and operating a Shared Use Facility in Electoral Area "A" pursuant to section 788(1)(e) of the Municipal Act.

2. **Service Area Boundaries**

- (a) The boundaries of the service area shall comprise of the boundaries of Electoral Area A.
- (b) The service area so defined shall be known as Lake Country Shared Use Facility.

3. **Participating Areas**

The participating area for the service is Electoral Area "A".

4. **Cost Recovery**

As provided for in section 804(1) of the **Municipal Act**, the annual costs of providing the service shall be recovered by:

- (a) the requisition of money under section 809.1 to be collected by a property value tax to be levied and collected under section 810.1, and
- (b) the imposition of fees and other charges that may be fixed by separate bylaw for the purpose of recovering these costs.

5. **Requisition Limit**

The maximum amount of money that may be requisitioned annually under section 804(1)(b) of the **Municipal Act** for the service provided under section 1, shall not exceed the greater of Three Hundred, Seventy-five Thousand dollars (\$375,000) or \$1.15 per \$1,000 of net taxable value of land and improvements for Regional Hospital purposes, within the service area.

6. This bylaw may be cited as "Regional District of Central Okanagan Lake Country Shared Use Facility Local Service Area Establishment Bylaw No. 507 , 1992".




