

REGIONAL DISTRICT OF CENTRAL OKANAGAN

BYLAW NO. 540

Being a bylaw to amend the Regional District of Central Okanagan Westbank Sewer Local Service Area No. 1 Establishment Bylaw No. 509 to increase the amount that may be requisitioned annually to provide for the additional costs for the financing of the construction of the expansion of the existing sewer works.

WHEREAS the Regional Board of the Regional District of Central Okanagan established by Bylaw No. 509, 1992 cited as the "Regional District of Central Okanagan Westbank Sewer Local Service Area No. 1 Establishment Bylaw No. 509, 1992", a local service area for the provision of sewer works within a portion of Electoral Areas 'G' and 'H';

AND WHEREAS the Regional Board of the Regional District of Central Okanagan deems it necessary to expand the existing sewer works to provide for additional servicing of properties within the boundaries of the local service.

AND WHEREAS the Regional Board deems it necessary and expedient to increase the amount that may be requisitioned annually to pay for the servicing of the increased debt.

AND WHEREAS the Regional District of Central Okanagan waives the assent of the electorate in accordance with Part 3, Section 16, Subsection 4 of the Waste Management Act.


NOW THEREFORE THE REGIONAL BOARD OF THE REGIONAL DISTRICT OF CENTRAL OKANAGAN in open meeting assembled enacts as follows:

1. The Regional District of Central Okanagan Westbank Sewer Local Service Area No. 1 Establishment Bylaw No. 509, 1992 is hereby amended as follows:
 - i. By deleting the figures \$120,000 in Section 4 and substituting therefore the figures \$820,000.
2. This Bylaw may be cited as the "Regional District of Central Okanagan Westbank Sewer Local Service Area No. 1 Amendment Bylaw No. 540, 1992".


