

REGIONAL DISTRICT OF CENTRAL OKANAGAN

BYLAW NO. 544

Being a bylaw to provide for remuneration of Directors and Alternate Directors

WHEREAS the provisions of Section 780, of the "Municipal Act" R.S.B.C. 1979, Chapter 290 provides that the Regional Board may by bylaw provide for the remuneration of Directors as follows:

1. The Regional Board may by bylaw provide -
 - (a) for remuneration of Directors and Alternate Directors;
 - (b) for additional remuneration for the Chairperson;
 - (c) for remuneration for members of committees of the Regional Board for each regularly constituted committee meeting attended, and the bylaw may limit the number of meetings for which remuneration may be paid.
2. A director or alternate director is entitled to be reimbursed for reasonable expenses incurred by him/her in connection with his/her attendance at meetings of the Regional Board. A director, alternate director or other committee member is entitled to that reimbursement in connection with attendance at committee meetings specified in subsection (1) (c) and engaging in business of the Regional District specifically authorized by the Regional Board.

NOW THEREFORE THE REGIONAL BOARD OF THE REGIONAL DISTRICT OF CENTRAL OKANAGAN IN OPEN MEETING ASSEMBLED, ENACTS AS FOLLOWS:

3. The Chairperson of the Board of Directors is entitled to receive a monthly remuneration of two thousand six hundred twenty five dollars (\$2,625.00).
4. Directors, other than the Chairperson, are entitled to receive a monthly remuneration of one thousand fifty dollars (\$1,050.00).
5. Alternate Directors are entitled to receive remuneration of seventy nine dollars (\$79.00) for each Regional Board meeting attended.
6. All Directors, Alternate Directors, including the Chairperson, are entitled to receive:
 - (a) fifty three dollars (\$53.00) for each half day regularly constituted committee meeting attended and one hundred five dollars (\$105.00) for each full day regularly constituted committee meeting attended.
 - (b) reasonable expenses incurred by him/her for attending meetings of the Regional Board, committee meetings and engaging in business of the Regional District specifically authorized by the Board; together with mileage for the use of their privately owned automobiles, at the following rates:



- i. 32 cents per km for cars and light pick-up trucks
- ii. 35 cents per km for 4 wheel drive trucks and heavy duty pick-up trucks

- 7. Bylaw #493 cited as the Regional District of Central Okanagan Board of Directors Remuneration Bylaw No. 493, 1989 is hereby repealed.
- 8. This bylaw may be cited as the "Regional District of Central Okanagan Board of Directors Remuneration Bylaw No. 544, 1992"




