

REGIONAL DISTRICT OF CENTRAL OKANAGAN

BYLAW NO. 597

A bylaw to establish a local service within a portion of Electoral Area "G" to provide for the operation and maintenance of a domestic water system in the West Kelowna Estates Subdivision.

WHEREAS a regional district may, by bylaw, establish and operate a local service under the provisions of Part 24 of the Municipal Act;

AND WHEREAS the Regional Board of the Regional District of Central Okanagan wishes to establish a local service for the purpose of operating and maintaining a domestic water system in a portion of Electoral Area "G";

AND WHEREAS in accordance with Section 795(2)(a)(i) of the Municipal Act, the Regional Board has received assent under Section 801, a sufficient petition for the service;

AND WHEREAS the Director of Area 'G' has consented, in writing, to the adoption of this bylaw;

NOW THEREFORE THE REGIONAL BOARD OF THE REGIONAL DISTRICT OF CENTRAL OKANAGAN IN OPEN MEETING ASSEMBLED ENACTS AS FOLLOWS:

1. The Regional District hereby establishes within Electoral Area "G", a local service for the operation and maintenance of a domestic water system to be known as the West Kelowna Estates Water System Local Service Area".
2. The participant in the local service, established under Section 1, is the portion of Electoral Area "G" as shown outlined on Schedule "A" attached hereto and forming part of the Bylaw.
3. The annual costs for the service established in Section 1 shall be recovered by:
 - a) The requisition of money under Sections 809.1 to be collected by a parcel tax to be imposed in the manner provided by Section 810.1(2).
 - b) The imposition of fees and other charges that may be fixed by a separate bylaw for the purpose of recovering these costs.
4. The maximum amount that may be requisitioned annually under Section 804(1)(b) for costs of the service shall be nil.
5. This bylaw may be cited as "Regional District of Central Okanagan West Kelowna Estates Water System Local Service Area Establishment Bylaw No. 597, 1994.



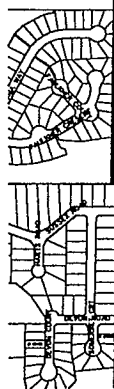
