BYLAW NO. 601

---

Being a bylaw to amend a Local Service Area within a portion of Electoral Areas 'G' & 'H', to provide for the operation and maintenance of streetlighting.

---

WHEREAS the Regional Board of the Regional District of Central Okanagan established by Bylaw No. 585, 1994 cited as the "Regional District of Central Okanagan Mission Ridge Streetlighting Local Service Area Amending Bylaw No. 585, a local service area for the provision of the operation and maintenance of streetlighting within a portion of Electoral Areas 'G' and 'H'.

AND WHEREAS it is deemed necessary to further amend the said Local Service Area to include Lots 1 - 34, Plan 50155, DL 1934.

AND WHEREAS a sufficient petition has been received by the Regional District of Central Okanagan for those lands to be added to the Mission Ridge Streetlighting Local Service Area;

AND WHEREAS the director of Electoral Areas 'G' and 'H' have consented in writing to the adoption of this bylaw.

NOW THEREFORE the Regional Board of the Regional District of Central Okanagan in open meeting assembled, enacts as follows:

1. The boundaries of the Streetlighting Local Service Area created under Bylaw No. 585, cited as the "Regional District of Central Okanagan Mission Ridge Streetlighting Local Service Area Amending Bylaw No. 585, 1994" are hereby extended to include Lots 1 - 34, Plan 50155, DL 1934.
2. Schedule 'A' of Bylaw No. 585 is hereby deleted in its entirety and replaced with Schedule "A" attached hereto.
3. This bylaw may be cited as the "Regional District of Central Okanagan Mission Ridge Streetlighting Local Service Area Amending Bylaw No. 601, 1994".


