

REGIONAL DISTRICT OF CENTRAL OKANAGAN

BYLAW NO. 608

Being a Bylaw to amend the Regional District of Central Okanagan Dog Regulation and Impounding Bylaw No. 366, 1988.

WHEREAS the Regional District of Central Okanagan has adopted the Regional District Dog Regulation and Impounding Bylaw No. 366, 1988;

AND WHEREAS it is deemed necessary to amend said Dog Regulation and Impounding Bylaw;

NOW THEREFORE the Board of the Regional District of Central Okanagan, in open meeting assembled, enacts as follows:

1) Amend Section 8(a), 8(b), 8(c) and 8(f) to read:

8 (a) For each spayed female or neutered male dog, where proof is provided that the dog has been spayed or neutered. \$16.00

8 (b) For each unspayed female or unneutered male dog. \$42.00

8 (c) For a kennel as defined hereabove and subject to the restrictions of the "Regional District Zoning Bylaw" \$125.00

or

The option of \$26.00 plus the individual license fee for each dog kept in the kennel

8 (f) For each Pit Bull Terrier, American Pit Bull Terrier, Pit Bull, Staffordshire Bull Terrier, American Staffordshire Terrier, Staffordshire Terrier, or any other dog of mixed breeding which includes any of the aforementioned breeds. \$105.00

2) This bylaw may be cited for all purposes as "The Regional District of Central Okanagan Dog Regulation and Impounding Amendment Bylaw No. 608, 1994.

3) These amendments shall come into affect January 1, 1995.






