

REGIONAL DISTRICT OF CENTRAL OKANAGAN

BYLAW NO. 618

Being a bylaw to convert a street light specified area to a local service area.

WHEREAS under Section 767(4) of the Municipal Act, a Regional District exercising a power to provide a service other than a general service is required to adopt a bylaw respecting that service which:

a) meets the requirements of Section 794 for an establishing bylaw, and

b) is adopted in accordance with the requirement of Section 802 as if it were a bylaw amending an establishing bylaw.

AND WHEREAS the Regional Board of the Regional District of Central Okanagan established by Bylaw No. 276, 1984, cited as the "Electoral Area 'A' Streetlighting Specified Area Establishment By-law No. 276, 1984", a specified area for the provision of streetlighting within a portion of Electoral Area 'A';

AND WHEREAS the Regional Board of the Regional District of Central Okanagan wishes to convert the aforesaid specified area to a local service;

NOW THEREFORE THE REGIONAL BOARD OF THE REGIONAL DISTRICT OF CENTRAL OKANAGAN in open meeting assembled enacts as follows:

1. The street light specified area created under Bylaw No. 276, cited as the "Electoral Area 'A' Streetlighting Specified Area Establishment By-law No. 276, 1984" is hereby established as a local service for Electoral Area 'A' as defined by Letters Patent, and known as the Electoral Area 'A' Streetlighting Local Service Area.

2. The participating area for the service is Electoral Area 'A'.

3. The maximum amount that may be expended for annual operating costs for the service provided under Section One shall not exceed \$0.0016 per \$1,000 of net taxable value of land and improvements within the service area.

4. The annual costs for providing the service shall be recovered by requisition of monies to be collected by a property value tax levied on the net taxable value of land and improvements for regional hospital purposes, within the service area.

5. This Bylaw may be cited as the "Regional District of Central Okanagan Electoral Area 'A' Streetlighting Local Service Area Establishment Bylaw No. 618, 1995".






