

REGIONAL DISTRICT OF CENTRAL OKANAGAN

BYLAW NO. 629

---

Being a bylaw to repeal a streetlighting local service bylaw.

---

WHEREAS under Section 802(1) a bylaw establishing a local service or extended service may be amended or repealed by bylaw adopted:

- a) in accordance with the requirements applicable to the adoption of the bylaw that it amends or repeals, or
- b) with the consent of at least 2/3 of the participants;

AND WHEREAS ads have been placed in a newspaper circulating in Electoral Area 'A', notifying the residents of the proposal to cancel three streetlights which are deemed to be no longer required, and asking that they submit their objections in writing to the Administrator of the Regional District of Central Okanagan;

AND WHEREAS no objections whatsoever have been received;

AND WHEREAS the Ministry of Transportation and Highways has agreed, in writing, to assume responsibility for two streetlights which are deemed to be required;

AND WHEREAS the Regional Board of the Regional District of Central Okanagan wishes to repeal Bylaw No. 618, 1995, cited as the Regional District of Central Okanagan Electoral Area 'A' Streetlighting Local Service Establishment Bylaw No. 618, 1995;

NOW THEREFORE THE REGIONAL BOARD OF THE REGIONAL DISTRICT OF CENTRAL OKANAGAN in open meeting assembled enacts as follows:

1. Bylaw No. 618, 1995 cited as the "Regional District of Central Okanagan Electoral Area 'A' Streetlighting Local Service Establishment Bylaw No. 618, 1995 is hereby repealed.
2. This Bylaw may be cited as the "Regional District of Central Okanagan Electoral Area 'A' Streetlighting Local Service Repeal Bylaw No. 629, 1995.






