BYLAW NO. 709

Being a bylaw to amend the Water Utility User and Maintenance Fee Bylaw.

WHEREAS the Regional Board of the Regional District of Central Okanagan adopted the "Regional District of Central Okanagan Water Utility User and Maintenance Fee Bylaw No. 664, 1996";

AND WHEREAS, subsequent to the adoption of Bylaw No.664, the Regional Board adopted the "Regional District of Central Okanagan Westshore Water System Local Service Area Establishment Bylaw No. 695, 1996" to provide for the acquisition, operation and maintenance of a domestic water system in the Westshore Subdivision;


AND WHEREAS the Regional Board deems it necessary and expedient to amend Bylaw No. 664 to include the Westshore Water System Local Service Area;

NOW THEREFORE the Regional Board of the Regional District of Central Okanagan in open meeting assembled, enacts as follows:



Billing will coincide with any other utility charge being levied by the Regional District, or on a semi-annual basis.
