

REGIONAL DISTRICT OF CENTRAL OKANAGAN

BYLAW NO. 733

A bylaw to expand the extended service of providing Dog Control.

WHEREAS the Regional District of Central Okanagan has established the Regional District of Central Okanagan Dog Control Extended Service Establishment Bylaw No. 425, 1990;

AND WHEREAS the Regional District of Central Okanagan wishes to expand the service area to include the District of Peachland and the District of Lake Country.

NOW THEREFORE the Regional District of Central Okanagan in open meeting assembled, enacts as follows:

- 1) Delete existing Section 1 of the Regional District of Central Okanagan Dog Control Extended Service Establishment Bylaw No. 425, 1990 in its entirety and replace it with a new Section 1 (a) and (b), as follows:
 1. a) The function of Dog Control created by the issuance of supplementary letters patent dated the 27 day of July, 1972, together with subsequent amendments, is hereby established as an extended service with the Electoral Areas G, I and Westbank as electoral participating areas and the Districts of Peachland and Lake Country as municipal participating areas.
 - b) The boundaries of the service area established under Section 1(a) shall include the boundaries of Electoral Areas G, I and Westbank and the District of Peachland and District of Lake Country.
- 2) This bylaw may be cited as the "Regional District of Central Okanagan Dog Control Extended Service Establishment Amendment Bylaw No. 733, 1997".




