

REGIONAL DISTRICT OF CENTRAL OKANAGAN

BYLAW NO. 741

Being a bylaw to amend a local service area.

WHEREAS the Regional Board of the Regional District of Central Okanagan established by Bylaw No. 404 cited as the "Regional District of Central Okanagan Joe Rich Fire Protection Local Service Area Establishment Bylaw No. 404, 1989" as amended, a local service for the purpose of providing fire protection to a portion of Electoral Area 'I';

AND WHEREAS the Regional Board deems it necessary to expand the said local service area to include the area shown as the shaded area on Schedule "A" attached hereto;

AND WHEREAS requests have been received by the Regional District of Central Okanagan to extend the Joe Rich Fire Protection Local Service Area boundaries to include additional parcels of land within a portion of Electoral Area I;

AND WHEREAS pursuant to section 812 of the Municipal Act, the Regional District of Central Okanagan has obtained a valid petition for the service;

AND WHEREAS the Director of Electoral Area 'I' has consented in writing to the adoption of this Bylaw;


NOW THEREFORE the Regional Board of the Regional District of Central Okanagan in open meeting assembled, enacts as follows:

1. The boundaries of the Joe Rich Fire Protection Local Service Area Establishment Bylaw No. 404, 1989, as amended, are hereby further amended to include such properties as outlined in Schedule A attached hereto and forming part of this Bylaw.
2. This Bylaw may be cited as the "Regional District of Central Okanagan Joe Rich Fire Protection Local Service Area Amendment Bylaw No. 741, 1997".



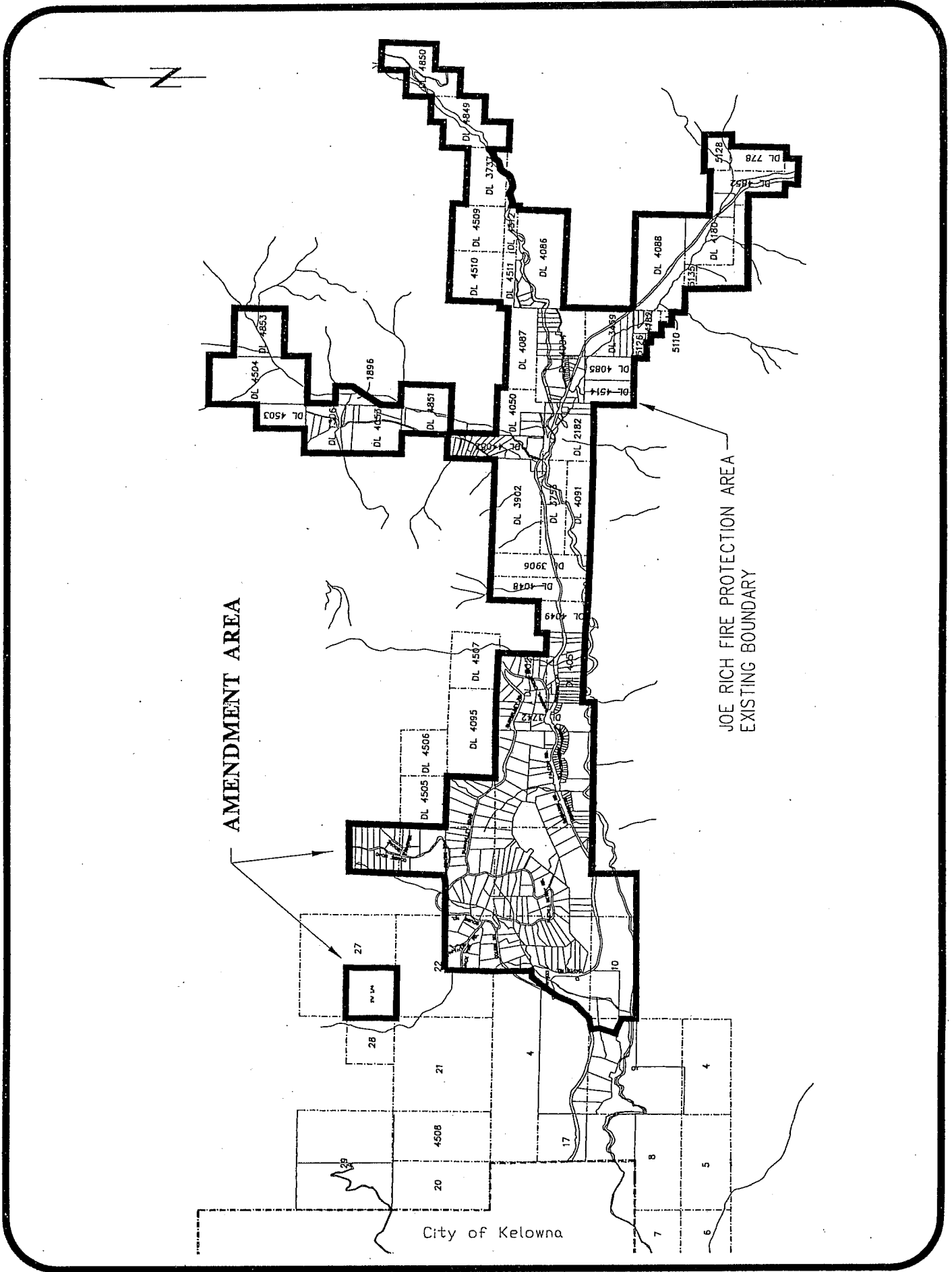
