

REGIONAL DISTRICT OF CENTRAL OKANAGAN

BYLAW NO. 745

Being a bylaw to expand the membership of the Electoral Area "G" North Advisory Planning Commission.

WHEREAS Bylaw No. 719 being "Regional District of Central Okanagan Electoral Area "G" North Advisory Planning Commission Bylaw No. 719, 1997" was adopted March 10, 1997;

AND WHEREAS Bylaw No. 719 provided for a total of six (6) members;

AND WHEREAS it is deemed necessary to expand that membership to a total of nine (9) members until such time as the Official Community Plan is completed;

NOW THEREFORE the Regional District Board of the Regional District of Central Okanagan in open meeting assembled, enacts as follows:


1. Section 2 of "Regional District of Central Okanagan Electoral Area "G" North Advisory Planning Commission Bylaw No. 719, 1997" is hereby deleted and the following substituted therefore:
 2. The Advisory Planning Commission shall consist of six (6) members, with an additional three (3) members who may be appointed for a specific term and/or purpose, all of whom shall be residents of Electoral Area "G" and on the recommendation of the Electoral Area Director, members shall be appointed subject to paragraph 3 herein, for a two year term by resolution of the Regional Board of the Regional District of Central Okanagan.
2. Section 3 of the "Regional District of Central Okanagan Electoral Area "G" North Advisory Planning Commission Bylaw No. 719, 1997" is hereby amended by adding the following after Section 3 (b):
 - c) Three additional persons may be appointed by resolution of the Regional Board of the Regional District of Central Okanagan for the specific purpose of reviewing the Official Community Plan, such term to commence January 1, 1998 and extend until the Official Community Plan Review or until December 31, 1998, whichever is sooner.
3. This bylaw may be cited as the "Regional District of Central Okanagan Electoral Area "G" North Advisory Planning Commission Amendment Bylaw No. 745, 1997."
