

REGIONAL DISTRICT OF CENTRAL OKANAGAN

BYLAW NO. 747

Being a bylaw to amend the Regional District of Central Okanagan Business Licensing and Regulations Bylaw No. 689, 1996.

WHEREAS the Regional District of Central Okanagan has adopted the "Regional District of Central Okanagan Business Licensing and Regulations Bylaw No. 689, 1996";

AND WHEREAS it is deemed necessary to amend said bylaw;

NOW THEREFORE the Regional District of Central Okanagan in open meeting assembled, enacts as follows:

1. Delete Part 2, Section 3 in its entirety and replace it with a new Part 2, Section 3, as follows:

The Director may issue the initial license when:

- a) The license is for a use which is allowed by a land use bylaw, by non-conformity provisions, or by a temporary commercial or industrial permit for the proposed location, and;
- b) Where the business is a premise, the premise is acceptable for such use in accordance with the bylaws and policies of the Regional District of Central Okanagan.

2. Delete Part 2, Section 6 in its entirety and replace it with a new Part 2, Section 6, as follows:

An application for a license shall be made on the form provided by the Regional District of Central Okanagan and shall include:

- a) The business name, premise address, mailing address and telephone number;
- b) The name, address and telephone number of the owner;
- c) A complete description of the business;
- d) The signature of the owner or operator of the business.

3. Delete Part 2, Section 7 in its entirety and replace it with a new Part 2, Section 7, as follows:

The granting of a license shall not in any way relieve the licensee from full responsibility for conducting or operating the business in accordance with the bylaws of the Regional District or other authorities having jurisdiction.

4. Delete Part 2, Sections 8 and 9 in their entirety.
5. Delete the words, "and the endorsements required by Section 8 and 9", from the first sentence of Part 2, Section 11.
6. Delete the words "by Schedule 'B'" from Part 2, Section 22.
7. Delete Part 2, Section 24 in its entirety and replace it with a new Part 2, Section 24, as follows:

To transfer an existing license to a different owner or premise, a new application must be completed and filed with the Regional District of Central Okanagan.

- 8. Delete the words "on a form acceptable to the Inspector" from Part 2, Section 30.4 and replace with the words "in the form attached as Schedule 'B'".
- 9. Delete Schedule 'B' in its entirety and replace with a new Schedule 'B' 1997.
- 10. This bylaw may be cited for all purposes as "Regional District of Central Okanagan Business Licensing and Regulations Amendment Bylaw No. 747, 1997".
- 11. This bylaw shall come into effect upon adoption.
