

REGIONAL DISTRICT OF CENTRAL OKANAGAN

BYLAW NO. 762

Being a bylaw to amend a local service area.

WHEREAS the Regional Board of the Regional District of Central Okanagan established Bylaw No. 651, 1995 cited as the "Regional District of Central Okanagan Westside Streetlighting Local Service Area", a local service area for the provision of the operation and maintenance of streetlighting within a portion of Electoral Area "G" and a portion of Electoral Area "Westbank";

AND WHEREAS the Regional Board of the Regional District of Central Okanagan has been petitioned to add parcels of land to the Westside Streetlighting Local Service Area to include:

Lots 11 - 15,	Plan 27320,	D.L. 506	O.D.Y.D;	and

Lots 5, 6 & 11,	Plan 23062	D.L. 3461	O.D.Y.D;	and

Lots 1-3, 5-7,	Plan 38002	D.L. 506	O.D.Y.D;	and
Lots 7 and 8,	Plan 40395	D.L. 506	O.D.Y.D;	and
Lots A and B,	Plan 43198	D.L. 506	O.D.Y.D;	and
Lot O,	Plan 42618	D.L. 4662	except Plans	KAP 47414,

KAP 47415 and KAP 52131.

AND WHEREAS the Directors of Electoral Areas "G" and "Westbank" have consented in writing to adoption of this Bylaw:

NOW THEREFORE THE REGIONAL BOARD OF THE REGIONAL DISTRICT OF CENTRAL OKANAGAN in open meeting assembled, enacts as follows:

1. The boundaries of the Streetlighting Local Service Area created under Bylaw No. 651, cited as the "Regional District of Central Okanagan Westside Streetlighting Local Service Area", are hereby extended to include:

Lots 11 - 15,	Plan 27320,	D.L. 506	O.D.Y.D;	and
Lot C,	Plan KAP 56266	D.L. 1117	O.D.Y.D;	and
Lots 5, 6 & 11,	Plan 23062	D.L. 3461	O.D.Y.D;	and
Lots 7 - 10,	Plan 23062	D.L. 506	O.D.Y.D;	and
Lots 1-3, 5-7,	Plan 38002	D.L. 506	O.D.Y.D;	and
Lots 7 and 8,	Plan 40395	D.L. 506	O.D.Y.D;	and
Lots A and B,	Plan 43198	D.L. 506	O.D.Y.D;	and
Lot O,	Plan 42618	D.L. 4662	except Plans	KAP 47414, KAP 47415 and KAP 52131;


shown as the shaded area on Schedule 'A' attached hereto and forming part of the Bylaw.



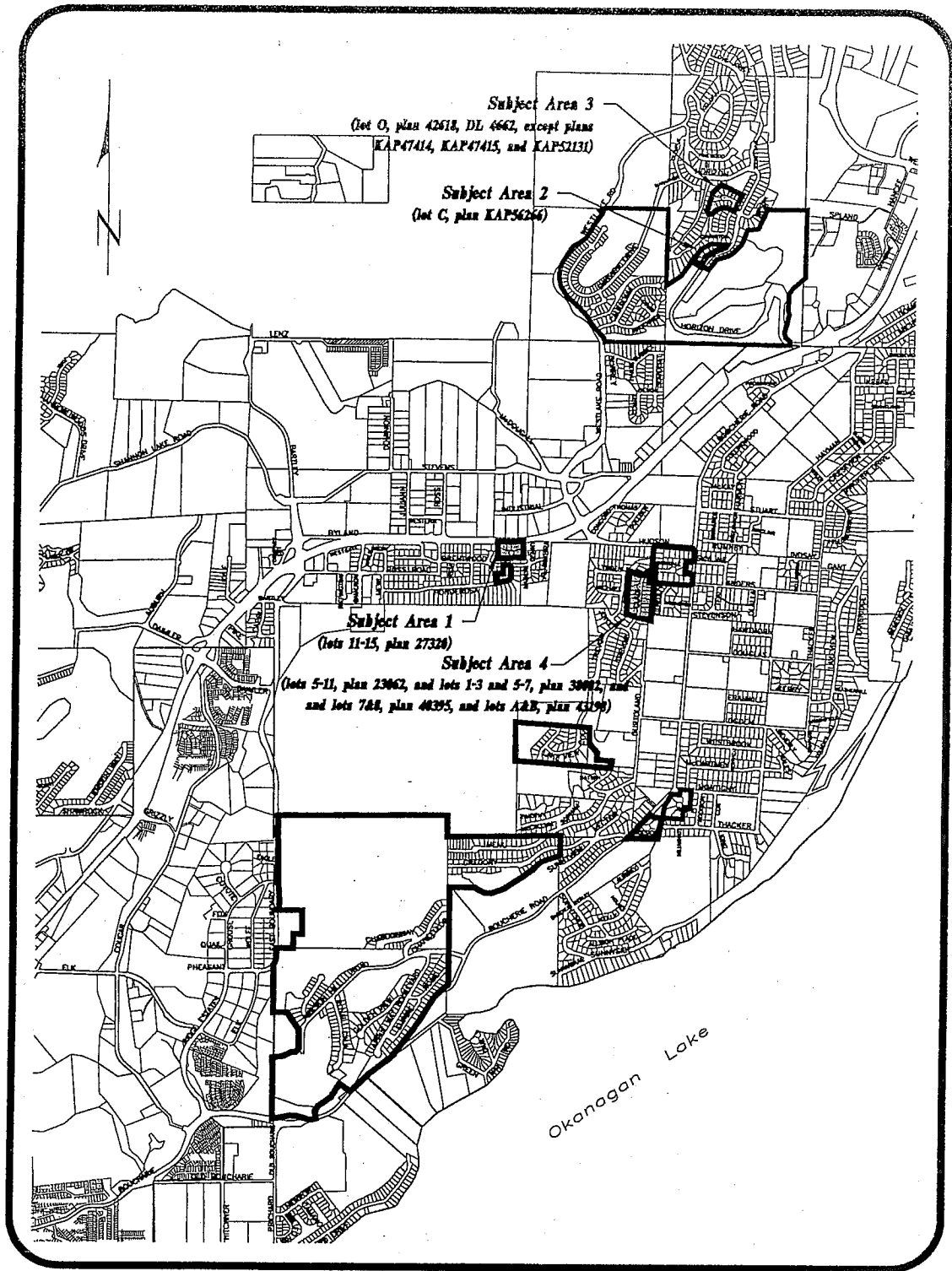
