#### BYLAW NO. 782

A bylaw to amend the Regional District of Central Okanagan Westside Community Parks Local Service Establishment Bylaw No. 549, 1993.

WHEREAS the Regional District of Central Okanagan Westside Community Parks Local Service Establishment Bylaw No. 549, 1993 was adopted by the Regional Board on the 5th day of April, 1993.

AND WHEREAS the Regional Board deems it advisable to amend the tax rate limit of the said Bylaw;

AND WHEREAS the Director of Area G and the Director of Area Westbank, being the participating members of this local service area, have consented to amending the tax rate;

NOW THEREFORE the Regional Board of the Regional District of Central Okanagan in open meeting assembled enacts as follows;

1. That the Regional District of Central Okanagan Westside Community Parks Local Service Establishment Bylaw No. 549, 1993 be amended by repealing and replacing Clause 5 with the following:

## 5. Requisition Limit

The maximum amount of money that may be requisitioned annually under Section 816 (1) of the Municipal Act for the service provided under Section 1, will not exceed \$0.45 per \$1,000 of net taxable value of land and improvements for Regional District purposes, within the service area.

2. This bylaw may be cited as the Regional District of Central Okanagan Westside Community Parks Local Service Establishment Amendment Bylaw No. 782, 1998.
