

REGIONAL DISTRICT OF CENTRAL OKANAGAN

BYLAW NO. 796

Being a bylaw to amend the Regional District of Central Okanagan Sewer System Local Service Area 303 - Mount Boucherie Loan Authorization Bylaw No. 684, 1996.

WHEREAS the Regional Board of the Regional District of Central Okanagan has adopted the "Regional District of Central Okanagan Sewer System Local Service Area 303 - Mount Boucherie Loan Authorization Bylaw No. 684, 1996" to provide for the borrowing upon the credit of the Regional District of Central Okanagan the sum of Nine Hundred Thousand Dollars (\$900,000) for the estimated cost of constructing a sewer system, including expenses thereto;

AND WHEREAS it has been found subsequent to the enactment of Bylaw No. 684 that the total cost of constructing the said sewer works is One Million, One Hundred and Sixty Thousand Dollars (\$1,160,000);

AND WHEREAS it is deemed necessary and expedient to amend said Bylaw No. 684 to increase the amount to be borrowed upon the credit of the Regional District of Central Okanagan from \$900,000 to \$1,160,000;

AND WHEREAS the Regional District of Central Okanagan Local Service Area 303 - Mount Boucherie Establishment Bylaw No. 683 has been amended by Bylaw No. 803;

AND WHEREAS the Regional District of Central Okanagan waives the assent of the electorate in accordance with Part 3, Section 18, Subsection 9 of the Waste Management Act;

AND WHEREAS the Director of Area 'G' has consented to the establishment of the local service area;

NOW THEREFORE the Regional Board of the Regional District of Central Okanagan in open meeting assembled, enacts as follows:


1. The "Regional District of Central Okanagan Sewer System Local Service Area 303 - Mount Boucherie Loan Authorization Bylaw No. 684, 1996" is hereby amended as follows:
 - a. By deleting the words and numbers "Nine Hundred Thousand Dollars (\$900,000)" in the Bylaw Title Clause and substituting the words and numbers "One Million, One Hundred and Sixty Thousand Dollars (\$1,160,000)".
 - b. By deleting the words and numbers "Nine Hundred Thousand Dollars (\$900,000)" in Subsection (a) of Section 1 and substituting the words and numbers "One Million, One Hundred and Sixty Thousand Dollars (\$1,160,000)".

2. This Bylaw may be cited as the "Regional District of Central Okanagan Sewer System Local Service Area 303 - Mount Boucherie Loan Authorization Amending Bylaw No. 796, 1998".
