

REGIONAL DISTRICT OF CENTRAL OKANAGAN

BYLAW NO. 847

A bylaw to establish a local service within a portion of Electoral Area 'G' to provide for sewer service, which includes design, construction, and operation of a sanitary sewer collection system to the Quails' Gate Estate Winery.

WHEREAS a regional district may, by bylaw, establish and operate a local service under the provisions of Part 24 of the Municipal Act;

AND WHEREAS the Regional Board of the Regional District of Central Okanagan wishes to establish a local service for the purpose of providing sewer service, which includes design, construction, and operation of a sanitary sewer collection system to a portion of Electoral Area G';

AND WHEREAS pursuant to Section 812 of the Municipal Act, the Regional Board has obtained a valid petition for the service;

AND WHEREAS the Director of Electoral Area 'G' has consented to the establishment of the local service area;

NOW THEREFORE THE REGIONAL BOARD OF THE REGIONAL DISTRICT OF CENTRAL OKANAGAN IN OPEN MEETING ASSEMBLED ENACTS AS FOLLOWS:

1. The Regional District hereby establishes within Electoral Area 'G' a local service for the purpose of providing sewer service, which includes design, construction, and operation of a sanitary sewer collection system, and to be known as the "Sewer System Local Service Area 606 – Lakeview".
2. The participant in the local service, established under Section 1, is Lot A, District Lot 581, ODYD, Plan 18934, a portion of Electoral Area 'G' shown outlined on Schedule "A" attached hereto and forming part of the Bylaw.
3. The annual costs for the service established in Section 1 shall be recovered by:
 - a) The requisition of money under Section 823 to be collected by a parcel tax imposed in the manner provided by Section 825(2).
 - b) The imposition of fees and other charges that may be set by separate bylaw for the purpose of recovering these costs.

- 4. The maximum amount that may be requisitioned under Section 816 (1) (b) for the service shall be \$7,000.
- 5. This bylaw may be cited as the "Regional District of Central Okanagan Sewer System Local Service Area 606 - Lakeview Establishment Bylaw No. 847, 1999.


