

REGIONAL DISTRICT OF CENTRAL OKANAGAN

BYLAW NO. 873

Being a bylaw to provide for the commutation of parcel taxes for providing ornamental street lighting to the Shamrock Drive/Ensign Way area in Electoral Area "Westbank".

WHEREAS a local service for the provision of ornamental street lighting has been established by the Regional District of Central Okanagan by Bylaw No. 868 cited as the "Regional District of Central Okanagan Shamrock Drive/Ensign Way Street Lighting Local Service Area Establishment Bylaw No. 868, 2000.

AND WHEREAS Bylaw No. 868 specifies that the annual cost of providing this service shall be recovered by the requisition of money under Section 823 of the Municipal Act, to be collected by a parcel tax to be imposed in the manner provided by Section 825 (2) and the imposition of fees and other charges;

AND WHEREAS Bylaw No. 868 further specifies that the Regional Board of the Regional District of Central Okanagan may by separate bylaw provide that the parcel tax imposition under Section 825 (2) may be commuted for payment in cash under the terms and conditions of that Bylaw;

NOW THEREFORE THE REGIONAL BOARD OF THE REGIONAL DISTRICT OF CENTRAL OKANAGAN IN OPEN MEETING ASSEMBLED ENACTS AS FOLLOWS:

- 1) That the parcel tax imposed under Section 825 (2) of the Municipal Act, as enacted by the Regional District of Central Okanagan Shamrock Drive/Ensign Way Street Lighting Local Service Area Establishment Bylaw No. 868, 2000 may be commuted for payment in cash pursuant to Section 825 (3) under the following terms and conditions:

Any person, whose parcel is subject to being specifically charged a parcel tax pursuant to Bylaw No. 868 of the Regional District of Central Okanagan, may commute the parcel tax imposed thereon, by making a one time payment in cash equal to the portion of the cost of providing the ornamental street lighting service assessed upon the parcel within thirty (30) days of receipt of written instructions from the Regional District of Central Okanagan.


- 2) This Bylaw may be cited as the "Regional District of Central Okanagan Shamrock Drive/Ensign Way Street Lighting Local Service Area Parcel Tax Commutation Bylaw No. 873, 2000.
