

REGIONAL DISTRICT OF CENTRAL OKANAGAN

BYLAW NO. 916

A bylaw to amend a service area.

WHEREAS the Regional Board of the Regional District of Central Okanagan established by Bylaw No. 801 cited as the "Regional District of Central Okanagan Sewer System Local Service Area 601 – Lakeview Establishment Bylaw No. 801, 1998" a local service for the purpose of providing sewer service, which includes design, construction, and operation of a sanitary sewer collection system, force main, and lift stations, to portions of Electoral Areas 'G' and 'Westbank';

AND WHEREAS the Regional Board deems it necessary to amend the said local service area by increasing the maximum amount that may be requisitioned annually to provide for the construction of the works;

AND WHEREAS the Regional District of Central Okanagan has an approved Liquid Waste Management Plan;

AND WHEREAS the Regional Board of the Regional District of Central Okanagan waives the assent of the electorate in accordance with Part 3, Section 18, Subsection (9) of the Waste Management Act;

AND WHEREAS the Directors of Electoral Areas 'G' and 'Westbank' have consented in writing to the adoption of this bylaw;

NOW THEREFORE the Regional Board of the Regional District of Central Okanagan in open meeting assembled enacts as follows:

1. The maximum amount that may be requisitioned annually as set out in Section 4 of the Regional District of Central Okanagan Sewer System Local Service Area 601 – Lakeview Establishment Bylaw No. 801, 1998 is hereby amended as follows:
 - i) by deleting the number \$12,000 and substituting therefore the number \$250,000.
2. This bylaw may be cited as the "Regional District of Central Okanagan Sewer System Local Service Area 601 – Lakeview Amending Bylaw No. 916, 2001.



CONSENT


We, the undersigned Directors of Electoral Areas "G" and "Westbank" of the Regional District of Central Okanagan, hereby consent to:
