

REGIONAL DISTRICT OF CENTRAL OKANAGAN

BYLAW NO. 967

A bylaw to establish and operate the service of numbering of buildings in the Electoral Areas of the Regional District of Central Okanagan.

WHEREAS a Regional District may, by bylaw, establish and operate a service under the provisions of Part 24 of the Local Government Act;

AND WHEREAS Section 797.1 of the Local Government Act provides for the establishment and operation of regulatory services within the Regional District;

AND WHEREAS the Regional Board of the Regional District of Central Okanagan wishes to establish the service of numbering of buildings within Electoral Areas 'Westbank', 'G', and 'I' pursuant to Section 801.5 of the Local Government Act;


AND WHEREAS the director of Electoral Areas 'Westbank', 'G' and 'I' have consented to the establishment of the service;

NOW THEREFORE THE REGIONAL BOARD OF THE REGIONAL DISTRICT OF CENTRAL OKANAGAN IN OPEN MEETING ASSEMBLED, ENACTS AS FOLLOWS:

1. The Regional District of Central Okanagan hereby establishes the service of numbering of buildings pursuant to Section 797.1 of the Local Government Act;
2. The boundaries of the service area shall be the boundaries of Electoral Areas 'Westbank', 'G' and 'I' as defined in the Letters Patent of the Regional District of Central Okanagan and amendments thereto;
3. Electoral Areas 'G', 'Westbank' and 'I' shall participate in this extended service as participating areas;
4. The annual costs for this service shall be recovered by the requisition of money to be collected by a property value tax levied and collected upon land and improvements within the participating areas under Section 806.1 of the Local Government Act;
5. The cost of providing the service shall be apportioned among the participating areas on the basis of the converted value of land and improvements in the participating areas;
6. This bylaw may be cited for all purposes as the "Regional District of Central Okanagan House Numbering Service Establishment Bylaw No. 967, 2002."
