

## Regional District of Central Okanagan

### Bylaw No. 1010

---

A bylaw to designate certain employees of the Regional District of Central Okanagan as "Municipal Employees" under the "Financial Disclosure Act".

---

WHEREAS the Regional Board deems it advisable to adopt a bylaw that provides for the designation of certain employees as "Municipal Employees" under the "Financial Disclosure Act".

NOW THEREFORE, the Regional District of Central Okanagan in open meeting assembled enacts as follows:

- 1 The persons holding the following positions are hereby designated "Municipal Employees" by the Regional Board of the Regional District of Central Okanagan to the "Public Officials and Employees Disclosure Act":
  - a) Director of Corporate Services
  - b) Director of Financial Services
  - c) Director of Engineering Services
  - d) Director of Planning Services
  - e) Director of Inspection Services
  - f) Deputy Chief Building Inspector
  - g) Director of Parks & Recreation
  - h) Director of Human Resources
  - i) Director of Economic Development
- 2 For the purpose of this bylaw, the above-named employees shall become municipal employees on the day that this bylaw receives final reading by the Regional Board.
- 3 Pursuant to Section 1 of the Act, the "Disclosure Clerk" shall be the Administrator of the Regional District of Central Okanagan

#### **Repeal**

- 4 Bylaw No. 131 cited as the "Regional District of Central Okanagan Municipal Employees Disclosure Bylaw No. 131, 1977", as amended by Regional District of Central Okanagan Municipal Employees Disclosure Amendment Bylaw No. 504, 1992, are hereby repealed.
