BYLAW NO. 1082

A bylaw to amend the Regional District of Central Okanagan Green Bay Sewer System Local Service Area Frontage Tax Assessment Roll Bylaw No. 592, 1994.

WHEREAS the Regional Board of the Regional District of Central Okanagan established by Bylaw No. 592 cited as the "Regional District of Central Okanagan Green Bay Sewer System Local Service Area Frontage Tax Assessment Roll Bylaw No. 592, 1994". A bylaw to provide for the preparation of frontage tax assessment roll under the provision of the Local Government Act;

AND WHEREAS the Regional Board of the Regional District of Central Okanagan deems it necessary to amend the Regional District of Central Okanagan Green Bay Sewer System Local Service Area Frontage Tax Assessment Roll Bylaw No. 592, 1994;

NOW THEREFORE THE REGIONAL BOARD OF THE REGIONAL DISTRICT OF CENTRAL OKANAGAN IN OPEN MEETING ASSEMBLED ENACTS AS FOLLOWS:


1. The Regional District of Central Okanagan Green Bay Sewer System Local Service Area Frontage Tax Assessment Roll Bylaw No. 592, 1994, is hereby amended as follows:
 - i) By deleting the Section 1 and replacing it with:

"1. A frontage tax per taxable foot shall be and is hereby imposed upon the owners of land within the service area which is capable of being connected to any sanitary sewer main, whether or not the parcel of land is connected to such sanitary sewer main, the aforesaid tax to be herein referred to as the "Frontage Tax"."
 - ii) By deleting Section 4, in its entirety and replacing it with:

"4. For the purposes of this bylaw, the following calculations have been made from a study of the lands within the service area.
a) the total actual frontage is 6639.33 feet
b) the total taxable frontage is 5971.68 feet"
2. This bylaw may be cited as the "Regional District of Central Okanagan Green Bay Sewer System Service Area Frontage Tax Assessment Roll Amending Bylaw No. 1082, 2004."

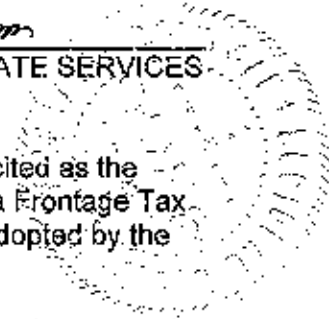
