

REGIONAL DISTRICT OF CENTRAL OKANAGAN

BYLAW NO. 1092

A bylaw to amend the "Regional District of Central Okanagan Sewer System Local Service Area 306 - Mount Boucherie Establishment Bylaw No. 800, 1998", by changing the established area from a local service to a service and to update referenced Sections from the Local Government Act.

WHEREAS the Regional Board of the Regional District of Central Okanagan established by Bylaw No. 800, a service within a portion of the Westside Electoral Area for the purpose of providing sewer service to the "Sewer System Local Service Area 306 – Mount Boucherie", generally the Pinewoods Villa Development Phases II and III;

AND WHEREAS the Regional Board of the Regional District of Central Okanagan deems it necessary to amend the bylaw to allow for changes in the Local Government Act;

NOW THEREFORE THE REGIONAL BOARD OF THE REGIONAL DISTRICT OF CENTRAL OKANAGAN IN OPEN MEETING ASSEMBLED ENACTS AS FOLLOWS:

1. The Regional District of Central Okanagan Sewer System Local Service Area 306 – Mount Boucherie Establishment Bylaw No. 800, 1998 is hereby amended as follows:
 - a) By deleting Section 1 in its entirety and replacing it with "The Regional District hereby establishes within the Westside Electoral Area a service for the purpose of providing sewer service and to be known as the "Sewer System Service Area 306 – Mount Boucherie".";
 - b) In Section 2 by removing the words "local service" and replacing them with "service";
 - c) In Section 3. a) by deleting the words "Section 823" and replacing them with "Section 806" and by deleting the words "Section 825(2)" and replacing them with "Section 806.1";
 - d) In Section 4 by deleting the words "Section 825 (2)" and replacing them with the words "Section 806.1(1)(b)";
 - e) In Section 5 by deleting the words "Section 816(1)(b)" and replacing them with the words "Section 806", and;
 - f) By deleting Section 6 and replacing it as follows:
"This bylaw may be cited as the "Regional District of Central Okanagan Sewer System Service Area 306 – Mount Boucherie Establishment Bylaw No. 800, 1998"."

2. This bylaw may be cited as the "Regional District of Central Okanagan Sewer System Service Area 306 – Mount Boucherie Establishment Amending Bylaw No. 1092, 2005".






