

REGIONAL DISTRICT OF CENTRAL OKANAGAN

BYLAW NO. 1093

A bylaw to authorize the borrowing of Ninety One Thousand dollars (\$91,000.00) for the purpose of providing sewer service to the Pinewoods Villa Development Phases II and III which is a portion of the Westside Electoral Area as established by the "Regional District of Central Okanagan Sewer System Service Area 306 – Mount Boucherie Establishment Bylaw No. 800, 1998", as amended.

WHEREAS the Regional Board of the Regional District of Central Okanagan established by Bylaw No. 800, as amended, a service known as the "Sewer System Local Service Area 306 – Mount Boucherie" within a portion of Westside Electoral Area for the purpose of providing sewer service to the Pinewoods Villa Development Phases II and III;

AND WHEREAS the cost of construction of the sewer service including expenses incidental thereto is the sum of Ninety One Thousand dollars (\$91,000.00) which is the amount of debt created by this bylaw;

AND WHEREAS the maximum term for which a debenture may be issued to secure the debt created by this bylaw is for a term not to exceed twenty (20) years;

AND WHEREAS the authority to borrow under this bylaw expires five (5) years from the date on which this bylaw is adopted;

AND WHEREAS the Directors of the Westside Electoral Area have consented to the adoption of this bylaw;

AND WHEREAS this bylaw repeals and replaces "Regional District of Central Okanagan Sewer System Local Service Area 306 – Mount Boucherie Loan Authorization Bylaw No. 814, 1999".

NOW THEREFORE THE REGIONAL BOARD OF THE REGIONAL DISTRICT OF CENTRAL OKANAGAN IN OPEN MEETING ASSEMBLED ENACTS AS FOLLOWS:

1. The Regional Board is hereby empowered and authorized in conjunction with the "Regional District of Central Okanagan Sewer System Service Area 306 – Mount Boucherie Establishment Bylaw No. 800, 1998", as amended:
 - a) To borrow upon the credit of the Regional District of Central Okanagan a sum not exceeding Ninety One Thousand dollars (\$91,000.00);
 - b) To acquire all such real property, easements, rights-of-way, licenses, rights or authorities as may be requisite or desirable for or in connection with the construction of the said design, construction, and operation of a sanitary sewer collection system to the Sewer System Service Area 306 – Mount Boucherie.
2. The maximum term for which debentures may be issued to secure the debt created by this bylaw is twenty (20) years.

3. The bylaw cited as "Regional District of Central Okanagan Sewer System Local Service Area 306 – Mount Boucherie Loan Authorization Bylaw No. 814, 1999" is hereby repealed.
4. This bylaw may be cited as the "Regional District of Central Okanagan Sewer System Service Area 306 – Mount Boucherie Loan Authorization Bylaw No. 1093, 2005".




