
1. In Section 3 of the Bylaw delete the words in parentheses "Schedules 2 through 17" and replace them with "Schedules 2 through 20".

4. Schedule 12 shall be deleted in its entirety and be replaced with a new Schedule 12, 2005, attached hereto and forming part of the bylaw.
5. Schedules 18, 19, and 20 attached hereto shall be added to and form a part of this bylaw.
