REGIONAL DISTRICT OF CENTRAL OKANAGAN

BYLAW NO. 1127

A bylaw to establish a service area within a portion of Central Okanagan East Electoral Area for the purpose of operation and maintenance of the community hall located on the Joe Rich Community Hall/Fire Hall site.

WHEREAS a regional district may, by bylaw, establish and operate a service under the provisions of Part 24 of the Local Government Act;

AND WHEREAS the Regional Board of the Regional District of Central Okanagan wishes to establish a service in a portion of Central Okanagan East Electoral Area for the purpose of operation and maintenance of the community hall located on the Joe Rich Community Hall/Fire Hall site;

AND WHEREAS pursuant to section 801.2 of the *Local Government Act*, a regional district may obtain approval of the electors for an establishing bylaw by seeking the assent of the electors by voting on a referendum in accordance with Section 85 of the *Community Charter*,

AND WHEREAS the Director of the Central Okanagan East Electoral Area has consented to the establishment of the service area;

NOW THEREFORE THE REGIONAL BOARD OF THE REGIONAL DISTRICT OF CENTRAL OKANAGAN IN OPEN MEETING ASSEMBLED ENACTS AS FOLLOWS:

1. Service Being Established

- a) The Regional District hereby establishes a service within a portion of the Central Okanagan East Electoral Area for the purpose of operation and maintenance of the community hall located on the Joe Rich Community Hall/Fire Hall site.
- b) The service area so defined shall be known as the "Joe Rich Community Hall Service Area".

2. Participating Area

The participants in the service established under Section 1, is that portion of the Central Okanagan East Electoral Area shown as the outlined area on Schedule 'A' attached hereto and forming part of the Bylaw.

3. Service Area Boundaries

The boundaries of the "Joe Rich Community Hall Service Area" are as shown outlined on Schedule 'A' attached hereto and forming part of this bylaw.

4. Cost Recovery

In accordance with Section 803 of the *Local Government Act*, the annual costs for the service established in Section 1 shall be recovered by:

- a) The requisition of money under Section 806 to be collected by a property value tax levied on land and improvements;
- b) Revenues received by way of agreement, enterprise, gift, grant or otherwise;
- c) The imposition of fees and other charges that may be set by separate bylaw for the purpose of recovering these costs.

5. Requisition Limit

The maximum amount that may be requisitioned annually for the service provided under Section 1 shall not exceed \$0.2082 cents per \$1,000.00 of net taxable value of land and improvements within the service area.

6. Citation

This bylaw may be cited as the "Regional District of Central Okanagan Joe Rich Community Hall Service Area Establishment Bylaw No. 1127, 2005".


