BYLAW NO. 1249

Being a bylaw to amend the Regional District of Central Okanagan Miscellaneous Fees and Charges Bylaw No. 1129


WHEREAS, the Regional District of Central Okanagan adopted the Regional District of Central Miscellaneous Fees and Charges Bylaw No. 1129, 2005;

AND WHEREAS it is deemed necessary to amend the Miscellaneous Fees and Charges Bylaw;

NOW THEREFORE THE REGIONAL DISTRICT OF CENTRAL OKANAGAN IN OPEN MEETING ASSEMBLED ENACTS AS FOLLOWS:

- 1. That Regional District of Central Okanagan Miscellaneous Fees and Charges Bylaw No. 1129 is hereby amended by:
  - a) deleting in *Schedule A, Utility Billing Searches*: Annual Fee for Online Web Access for Self-Service Searches - \$200.00 (unlimited searches), and replacing it with Annual Fee for Online Web Access for Self-Service Searches - \$50.00 (unlimited searches).
- 2. This bylaw may be cited as the "Regional District of Central Okanagan Miscellaneous Fees and Charges Amendment Bylaw No. 1249, 2008.


